

Please refer to the above cited subject and letters seeking prior approval of the Central government for the diversion of 3.01 ha of Forest land for non-forestry purpose in accordance with section 2 of Forest (Conservation)Act, 1980.

- 2. After careful examination of the proposal of the UT Administration of J&K, in-principle approval is hereby being conveyed for the diversion 3.01 ha of Forest land in Kishtwar Forest Division in favour of L&T Limited Heavy Civil INFRAIC for Pakul Dul Hydro Electric Power Projects, District Kishtwar, UT of Jammu and Kashmir, subject to the following conditions:
- (A). Conditions which need to be complied prior to handing over of forest land by the UT Forest Department to the L&T Limited Heavy Civil INFRAIC (User agency):
 - i. Cost of compensatory afforestation as per CA scheme may be realized from user agency.
- Net Present Value (NPV) of the forest land being diverted for non-forestry purpose may be realized from the user agency, as per Ministry's directions issued vide letters No. 5-3/2007-FC dated 5th February 2009 and Hon'ble Supreme Court of India's Order dated 30th October 2002, 28th March, 2008, 24th April, 2008 and 9th May 2008;
- iii. As per the orders of the Government of India vide letter No. 5-2/2010-CAMPA 24.06.2011, the Net Present Value (NPV) of the forest land and all other CA levies shall be deposited through web portal of Ministry of Environment, Forest and Climate Change www.parivesh.nic.in.

- iv. User Agency should ensure that the compensatory levies (CA cost, NPV etc.) are deposited through challan generated online on web portal and deposited in appropriate bank only. Amount deposited through other mode will not be accepted as compliance of the Stage-I clearance.
- v. The user agency shall provide an undertaking to handover this forest land free from all encumbrances to the forest department after completion of work or after 8 years from the issuance of the working permission, whichever is earlier;
- vi. The complete compliance of the FRA, 2006 shall be ensured by way of prescribed certificate from the concerned District Collector.
- (B) Conditions which need to be strictly complied on field after handing over of forest land to the user agency by the State Forest Department but the compliance in form of undertaking shall be submitted prior to Stage-II approval
 - i. Legal status of the forest land will remain unchanged;
 - ii. Efforts should be made to fell minimum number of trees and in any case not more than 166 trees shall be felled. Any felling shall only be done under strictvigilance of forest department after issuance of felling permission from the concerned DFO;
- iii. Compensatory afforestation will be carried out over Degraded Forest land (DFL) upon 6 ha of land on Comp No. 2a/N, Village-Kwartangi, Tehsil-Nagseni, District-Kishtwar, as per proposed CA scheme;
- iv. Compensatory afforestation will be done within one year from the date of issue of final approval over the extent of land as approved, out of the funds provided the user agency;
- v. The UT Govt shall upload the KML files of the degraded forest area accepted for raising compensatory afforestation as well as the forest area proposed for diversion in the extant proposal in the E-Green watch portal;
- vi. The forest land being diverted shall be properly demarcated using RCC boundary pillars with forward/backward bearing and the GPS coordinates inscribed on them at the project cost.
- vii. The DFO shall ensure that no muck will be dump in the forest land in context of undertaking given by UA of not generating any muck during the construction of segment casting yard;
- viii. The forest land will not be used for any other purpose than that mentioned in the proposal;
 - ix. The forest land proposed to be diverted shall under no circumstances be transferred to any other agency, department, or person without approval of the Ministry of Environment Forest and Climate Change;
 - x. The layout plan of the proposal shall not be changed without the prior approval of the Ministry of Environment Forest and Climate Change;
- xi. No damage will be done to the adjoining forest land including flora and fauna during the project implementation / operation;

- xii. No labour camp shall be established on the forest land;
- xiii. The user agency shall pay additional amount of NPV as and when increased on the order of Hon'ble Supreme Court;
- xiv. The User Agency shall provide fuel preferably alternate fuels to the labourers and the staff working at the site so as to avoid any damage and pressure on the nearby forest areas;
- xv. The user agency shall handover this forest land free from all encumbrances to the forest department after completion of work or after 8 years from the issuance of the working permission, whichever is earlier;
- xvi. The Ministry of Environment Forest and Climate Change may revoke/suspend the clearance, if implementation of any of the above conditions is not satisfactory. State/UT government will ensure compliance of these conditions through forest department.

In compliance with the Ministry of Environment and Forest (MoEF), Govt of India's letter no. 11-9/98-FC (pT) Dt:- 3rd Aug 2009, wherein the MoEF issued guidelines on submission of evidences for having initialed and competed the process of settlement of rights under the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act 2006, (FRA for short) on the Forest Land proposed to be diverted for Non Forest purposes read with MoEF's letter Dt;-5th Feb 2013, wherein, MoEF issued certain exemption/ relaxation in respect of linear projects, it is certified that 3.0Hectare of Forest land is proposed to be diverted in Panchayat Kwar, in favour ofM/S L&T (Contractor for CVPP for Pakal Dul HEPP) Kishtwar, required for the construction of head race tunnel (HRT-TBM) works of Pakal Dul HEPP District Kishtwar.

It is further certified that:

- (a) The complete process of recognition and vesting of forest rights under the FRA has been carried out for the entire 3.0 Hectare in Panchayat Kwarof forest land proposed for diversion. The proposed area does not cover any part of the FRA-2006, since there is no any claim in this area as on date. A report in this regard from Sub Division Level FRC Committee Kishtwar) including report of BDO Nagsenialong with recommendation / report of Gram Sabha Resolution (duly signed by FRC committee members) is enclosed as Annexure "A"
