





I, (Sunil Kumar Dogra) Executive Engineer PWD (R&B) Const. Div.No. III Jammu do hereby undertake to comply the following conditions: -

- i) Legal status of the forest land shall remain unchanged;
- ii) Efforts should be made to fell minimum number of trees;
- iii) The CA will be carried out on degraded forest land as per the CA scheme and the funds will be provided by the user agency. The plantation of 1 000 trees per ha (or proportionately less if forest area diverted is less than 01 Ha) will be done within one year from the date of issue of the approval;
- iv) The layout plan of the proposal shall not be changed without prior approval of Central Government;
- v) No labour camp shall be established on the forest land;



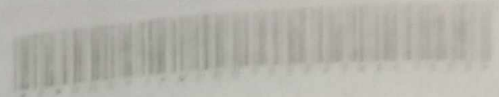



In reference to letter No.11-9/98-FC (pt) dated 3rd August 2009 of Ministry of Environment and Forests (MoEF), Government of India's wherein guidelines on submission of evidences have been issued for having initiated and completed the process of settlement of rights under the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 ('FRA', for short) on the forest land proposed to be diverted for non-forest purposes read with MoEF's letter dated 5th February 2013 wherein MoEF issued certain exemption/relaxation in respect of linear projects, it is certified that:

- (a) The .75 Ha of forest land is proposed to be diverted in favour of construction of road from Kathar Bridge to Bal Saroh (Kund Kamyari) Km 1st RD.0 to Km 3rd RD.1000.
- (b) Tehsildar Reasi vide No.Teh/Rsi/2023-24/N/114 dated 13-07-2023 has communicated that no rights under FRA 2006 have been recognized to any community in village Gungus and **No recognized rights of Primitive Tribal Groups (PTG) and Pre Agricultural Communities (PAC) shall be affected in diversion of forest land for non forest use for construction of road from Kathar Bridge to Bal Saroh (Kund Kamyari) Km 1st RD.0 to Km 3rd RD.1000.**

Hence, Forest Right Act certificate is issued for forest land required for **construction of road from Kathar Bridge to Bal Saroh (Kund Kamyari) Km 1st RD.0 to Km 3rd RD.1000, District Reasi.**
