With reference to the above cited subject and reference, it is submitted that the proposal for diversion of 1.137 Ha of forest land **Construction and Upgradation of Bijarni to Lal Draman link road from Km – 10th RD 600** has been accorded the In-principal approval vide Regional Officer Dy. DGF (Central) & i/c IRO Jammu's Office **File No.: - 9-JKB-008/2023-Jammu Dated: - 04/2023.** subject to conditions mentioned below whose compliance has been completed an part of user agency i.e. PWD (R&B) Division Doda and same has been detailed para wise below:






UNDERTAKING FOR COMPLIANCE TO BE SUBMITTED PRIOR TO STAGE-II

APPROVAL

On behalf of PWD R&B Spl Sub-Division Doda in respect to proposal for diversion of 1.137 Ha of forest land for construction and up-gradation of Bijarni to Lal Draman link road Km 10th RD (600) under PWDR(&B) Division Doda, UT of Jammu and Kashmir (Proposal No.9-JKB-008/2023-Jammu), hereby undertake to comply the below mentioned conditions:

1. That the Legal Status of land will remain unchanged.
2. That the efforts should be made to fell minimum number of trees. Any felling shall only be done under the strict supervision of State Forest Department after issuance of felling permission from concerned DFO and the cost of felling of trees shall be deposited by the User agency with the State Forest Department.
3. The layout plan of the proposal shall not be changed without prior approval of Central Government.
4. The Forest land shall not be used for any purpose other than that specified in the project proposal.
5. The forest land proposed to be diverted shall under no circumstance be transferred to any other agency, department, or person without approval of the Ministry of Environment, Forest and Climate Change.
6. No labour camp shall be established on the forest land.
7. Sufficient firewood, preferably by the alternate fuel, shall be provided by the user agency to the labours after purchasing the same from the State Forest Department or the Forest Development Corporation or any other legal source of alternate fuel.
8. The boundary of the diverted forest land shall be suitable demarcated on ground at the project cost, as per the directions of the concerned Divisional Forest Officer.
9. No additional or new path will be constructed inside the forest area for transportation of construction materials for extraction of the project work.
10. The User Agency shall pay additional amount of NPV as and when increased by the order of Hon;ble Supreme Court.
11. The User Agency shall obtain Environment Clearance as per the provision of the Environment (Protection) Act 1986, if applicable.
12. The acquired 03 dumping site should be prepared appropriately as per approved muck disposal plan given in the proposal before start of dumping to prevent downhill side of the muck.
13. The User Agency shall raise strip plantation on both sides and central verge of the road as per IRC norms.
14. Speed regulating will be erected along the road at regular intervals in the Forest Areas.
15. Any other condition that the Ministry of Environment, Forest and Climate Change may stipulate from time in the interest of conservation, protection and development of forest and wildlife.
16. The Ministry of Environment, Forest and Climate may revoke/suspend the clearance, if implementation of any of the above conditions is not satisfactory. The State Govt. will ensure compliance of these conditions through Forest Department.
