

Please refer to the case of diversion of 0.645 ha of forest land for construction of Road from Dhanu (Dhanwale) to Barigairian (Forol) via Gaihar Ramnagar in Ramnagar Forest Division as per online proposal referred above.

2. I am directed to convey in-principle approval for diversion of 0.645 ha of forest land for construction of Road from Dhanu (Dhanwale) to Barigairian (Forol) via Gaihar Ramnagar in Ramnagar Forest Division subject to the fulfilment of following terms and conditions:-

(A) Conditions which need to be complied prior to handing over of forest land by the J&K Forest Department.

- i) Cost of compensatory afforestation as per scheme may be realized from the user agency;
- ii) Net Present Value (NPV) of the forest land being diverted for non-forestry purpose may be realized from the user agency, as per MoEF&CC directions issued vide letters No. 5-3/2007-FC dated 5th February 2009 and Hon'ble Supreme Court of India's Order dated 30th October 2002, 28th March, 2008, 24th April, 2008 and 9th May 2008;
- iii) The Net Present Value (NPV) of the forest land and all other CA levies shall be deposited through web portal of Ministry of Environment, Forest and Climate Change www.parivesh.nic.in;
- iv) User agency should ensure that the compensatory levies (CA cost, NPV, etc.) are deposited through challan generated online on web portal and deposited in appropriate bank only. Amount deposited through other mode will not be accepted as compliance of the Stage-I clearance;
- v) Original copy of FRA certificate to be submitted;
- vi) Divisional Forest Office shall furnish undertaking that the approved CA sites will not be changed without the approval of the Competent Authority.
- vii) The CEO State CAMPAs shall furnish undertaking that the funds under State CAMPAs will be released to Divisional Forest Officer as per approved CA scheme.
- viii) Violation of any of these conditions will amount to violation of Forest (Conservation) Act, 1980 and action would be taken as per law.

(B) Conditions which need to be strictly complied on field after handing over of forest land to the user agency by the J&K Forest Department but the compliance in form of undertaking shall be submitted prior to Stage-II approval:

- i) Legal status of the forest land shall remain unchanged;
- ii) Efforts should be made to fell minimum number of trees;

It is further certified that:

- (a) The complete process for identification and settlement of rights under the FRA has been carried out for the entire 0.645 hectare of forest area proposed for diversion. As per MoEF issued vide No. F. No. 11-9/98-FC(9pt) dated 5th Feb. 2013 for linear projects like constructions of **roads, canals, laying of pipelines/optical fibre and transmission lines etc.**, there is no requirement of resolution of the Gram Sabha of the area, based on full and prior information of the project and a public hearing, endorsing that the project is in the interest of the people living on the forest land, use of which is proposed to be diverted for non-forest purpose;
- (b) The proposal does not involve recognized right of Primitive Tribal Groups and Pre-agricultural communities as reported by Tehsildar Ramnagar vide No. 365/OQ dated 08.07.2022.
