### "UNDERTAKING FOR COMPLIANCE TO BE SUBMITTED PRIOR TO STAGE-II APPROVAL"


I on behalf of PMGSY Division Thathir in respect to proposal for diversion of **0.88 Ha** of Forest Land for Construction of road from Kharangal to Chounri in Bhaderwah Forest Division is hereby Undertake to Comply the below mentioned conditions.

1. Legal Status of the forest land shall remain unchanged.
2. Efforts should be made to fell minimum number of trees. The trees shall be felled under the strict supervision of the UT Forest Department and the cost of felling of trees shall be deposited by the User Agency with UT Forest Department/J&K FDC as applicable.
3. Compensatory afforestation will be carried out over **0.88 Ha** Degraded Forest land (DFL) in Compartment **14/J** as per approved CA scheme. As far as possible a mixture of local indigenous species shall be planted and monoculture of any species may be avoided.
4. The layout plan of the proposal shall not be changed without prior approval of Central Government.
5. No labour camp shall be established on the forest land.
6. Sufficient firewood, preferable the alternate fuel, shall be provided by the User Agency to the labourer after purchasing the same from the State Forest Department or the Forest Development Corporation or any other legal source of alternate fuel.
7. No additional or new path will be constructed inside the forest area for transportation of construction materials for execution of the project work.
8. The period of diversion under this approval shall be co-terminus with the period of lease to be granted in favour of the user agency or the project life, whichever is less;
9. The forest land shall not be used for any purpose other than that specified in the project proposal.
10. The forest land proposed to be diverted shall under no circumstances be transferred to any other agencies, department or person without prior approval of Govt. of India.
11. Any other condition that the Ministry of Environment, Forest & Climate Change may stipulate from time to time in the interest of conservation, protection and development of forests & wildlife.
12. User Agency shall obtain Environment Clearance or any other clearance, if applicable under any act/rule/order/guideline etc for the proposal.
13. After Receipt of the Compliance Report on fulfillment of the conditions under Para-2 above, final approval order shall be given under Section-2 of the Forest (Conservation) Act, 1980. The use of forest land will be allowed till final approval is accorded.
