In light of the directions issued by your goodself in the letters (2) cited above and followed by the additional information /clarification /documents on the 08 points as sought for by the Government of India, Ministry of Environment, Forest & Climate Change, New Delhi, in its letter dated:19-07-2022 cited under reference (1) supra, after examining the compliance report on the various conditions as stipulated in the in-principle (Stage-I) approval accorded vide its order dated:15-10-2019 respectively in respect of diversion of 19.206 ha for forest land in Swamy Malai (SM) Forest Block in Sandur South Range, Sandur Taluk, Ballari District for establishing Downhill Pipe Conveyor System from haddinapade iron ore mine (ML No.2516) to proposed railways siding at Dharmapura in favour of Sri B.Rudra Gouda, Sandur, Ballari District as legal representative of late Sri B.Kumaragouda, Sandur. Accordingly, the Deputy Conservator of Forests, Ballari division, Ballari was directed vide this office letter (3) cited above to submit the point-wise additional information /clarification /documents on the 08 points as sought for by the Government of India, Ministry of Environment, Forest & Climate Change, New Delhi.

Accordingly, the Deputy Conservator of Forests, Ballari in his self contained letter (4) cited above has submitted the point-wise additional information /clarification /documents on the compliance report which was already submitted to the higher authorities, as sought for by the Government of India in its letter dated:19-07-2022 duly obtaining from the above user agency and later on getting them verified from his end for taking further needful action in the matter.

On verification of the additional information /clarification /documents as submitted by the Deputy Conservator of Forests, Ballari, the compliance of FRA 2006 has been obtained by the user agency, the translated english version of mutation register and RTC's, the encumbrance certificate of the patta lands which have been earmarked for raising compensatory afforestration plantation and other essential information as called for therein by the Government of India.

With reference to the above subject, the Ministry of Environment Forests and Climate Change, Government of India has accorded 'in principle' approval (Stage-I) under Section-2 of Forest (Conservation), Act-1980 for diversion of 19.206 hectare of forest land in Swamy Malai (SM) Forest Block in Sandur South Range, Sandur taluk, Ballari District for establishing Downhill Pipe Conveyor System from Haddinapade Iron Ore Mine (ML No. 2516) to proposed railways siding at Dharmapura in favour of Shri B. Rudra Gouda, Sandur, Ballari District, as Legal representative of late Sri. B. Kumaragouda, Sandur vide letter under Ref (1). In this regard, this office had already submitted the compliance report to conditions imposed in Stage-I approval vide letter under Ref (6).

Further, the Government of India has raised the EDS Query with certain shortcomings vide letter under Ref(7). In connection with, the Principal Chief Conservator of Forests (Forest Conservation), Bengaluru and the Chief Conservator of Forests, Ballari Circle, Ballari have directed the undersigned to submit information duly obtaining the same from the User Agency vide letters under Ref(8) & (9). In this regard, the office of the undersigned has directed the User Agency to submit the information as sought by the Government of India. The same has been received vide letter under Ref(10).

Therefore, I am herewith submitting the information as sought by the Government of India.

		As per report submitted by the User Agency & field officers and upon verification of records, it is found that, there is ovrlap of this instant proposal with M/s Karnataka State Mineral Corporation Limited Conveyor belt proposal No. FP/KA/MIN/36386/2018. Subsequently, the above mentioned proposal of M/s. KSMCL (proposal No. FP/KA/MIN/36386/2018) has been withdrawn. Afterwords, the M/s. KSMCL has submitted the new proposal for conveyor belt vide online proposal No. FP/KA/MIN/48923/2020 [FORM-A]. Copy of the Google earth map			

enclosed as **Annexure -V.** In this proposal there is no overlap between M/s. KSMCL and M/s. B.Kumargouda Conveyor belt proposals.

Hence, the issue of overlap with M/s Karnataka State Mineral Corporation Limited does not arise.

Initally, Managing Director, Karnataka Mining Environment Restoration Corporation(KMERC). Bangalore has applied for diversion of 4.07 ha Forest area for subline proposal in Parivesh portal-1. (Proposal No. FP/KA/MIN/144985/2021 [FORM-A]).

that, M/s. Managing Director, Karnataka Mining Environment Restoration Corporation(KMERC), Bangalore has applied for diversion of forest land over an extent of 5.81 Ha for Construction / setting-up of Dharmapura GCT, near Sharmapura Village & Railway Sub-line from Lakshmipura to Dharmapura GCT (Proposal No.FP/KA /RAIL/406932/2022). After the joint survey conducted, the area for this proposal is revised to 6.246 ha. Out of this, 1.9397 ha is overlapping with Conveyor belt proposed area of M/s. B.Kumaragoud ML No. 2516 which has already got Stage-I approved vide F.No. 8-113/2013-FC(Vol) Dt. 15.10.2019 (vide Proposal No. FP/KA/MIN/36226/2018) and 0.8644 ha is overlapped with KSMCL Conveyor belt proposal (vide Proposal No. FP/KA/MIN/48923/2020).
