With reference to the subjected , we would like to inform you that the Government of India has accorded the "In -Principle" (Stage-I) approval under Section 2 of the Forest (Conservation) Act, 1980 for the diversion of 0.789 Ha of forest land in Anagodu Sec-4 area in Davanagere Forest Division for Bharamasagara LIS, Construction of raising main pipeline (Ch: 36.225 to Ch: 37.550 Km) in favour of the Executive Engineer, Karnataka Neeravari Nigam Limited (KNNL), Bhadra Canal Division, Davanagere, subject to certain conditions stipulated therein.
