With reference to the above cited subject, vide ref(3), the Regional Empowered Committee constituted under sub-rule 4A of the Forest (Conservation) Rules, 2003 in its meeting held on 20/01/2023, has given in **Principal approval /Stage-I clearance** for diversion of 5.724414 Ha. of forest land for the work of "<u>Widening to two lane with paved shoulders from Km: 24.60 to 70.063 of Mudigere Kadur section NH-173 in the state of Karnataka. (Job No. NH-173-KNT-2017-18-873)".</u>

Vide demand notice cited under ref(4), by your kind self, it was instructed to make payment of Rs.1,75,42,982/- (Net present value of Eco Class-III, dense Forest amounting to Rs:70,32,958/- and Compensatory afforestation Charges amounting Rs.1,05,10,024/-

I am directed to refer to the State Government's letter No. FEE 71 FLL 2022 (e) dated 15/06/2022 and 19/12/2022 seeking prior approval of the Central Government under Section'2' of the Forest (Conservation) Act, 1980 for the above project.

The proposal was examined by the Regional Empowered Committee constituted under sub-rule (1) of rule 4A of the Forest (Conservation) Rules, 2003 in its meeting held on 20/01/2023.
