

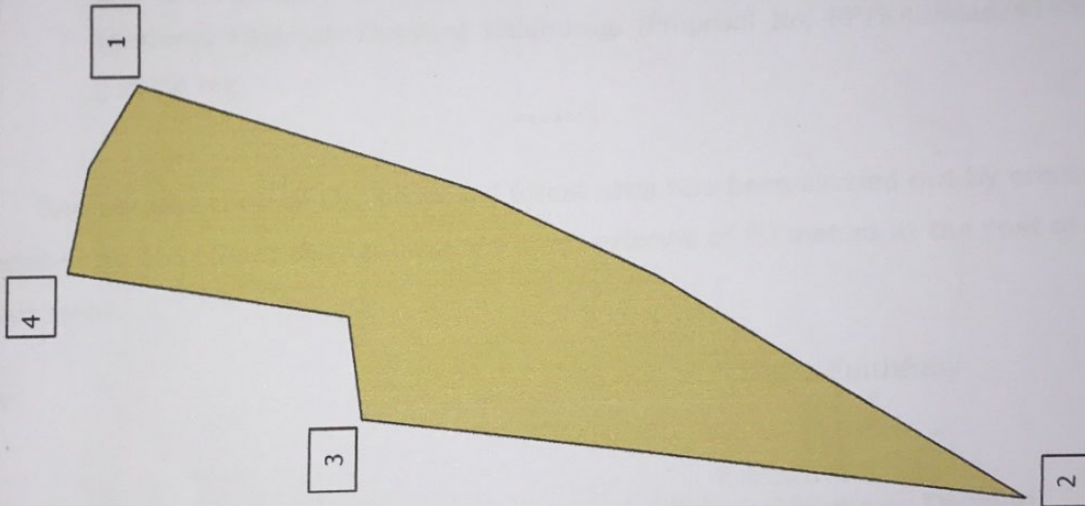




CENTER LINE MARK STARTING POINT @ 0.393



In compliance of the Ministry of Environment and Forests (MoEF) Government of India's Letter No. 11-9/98-FC(pt) dated 3rd August 2009 wherein the MoEF issued guidelines on submission of evidences for having initiated and completed the process of settlement of right under the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Right) Act 2006 (FRA for short) on the forest land proposed to be diverted for non forest purposes read with MoEF's letter dated 5th February 2013 wherein MoEF issued certain relaxation in respect of liner projects it is certified that **0.3221 Hactares** of forest land proposed to be diverted in favour of **Executive Engineer, Public Work, Port & Inland Transport Department (national Highway Division) Kalaburagi for the Construction of four lane road over bridge (ROB)** (propose for diversion of forest land) in Bidar district falls within jurisdiction of Naubad Villages in Bidar Tahasils.

It is further certified that :

1. The complete process for identification and settlement of right under the FRA has been carried out for the entire **0.3221 Hectares** of forest area proposed for diversion
A copy of records of all consultation and meetings of the Forest Rights Committee (s) Gram Sabha(s) sub division level committee and the district level Committee are enclosed as annexure 1 to annexure 3.
2. The diversion for forest land for facilities managed by the Government as required under section 3 (2) of the FRA have been completed and the Town Ward No. 18, have given their consent to it.
