With reference to the above cited subject, It is brought your notice that the Government of India, Ministry of Environment, Forests & Climate Change, Regional Office (Southern Zone), Koramangala, Bengaluru has accorded In-principle approval (Stage-I) for diversion of 0.8955 ha. of Forest Land in Ankasandra State Forest (Sy. No. 16 & 17) of Kurubarahalli Village and Sy. No. 19 of Thalekoppa Village) in Gubbi Taluk, Tumakuru District in favour of M/s Adani Green Energy (UP) Ltd., for a period of 20 years vide letter cited at ref (2).

As per condition no. 3 of the approval, the user agency has to pay the cost of raising plantation ten times the number of trees to be felled i.e., 237 trees for raising tall seedlings and maintain the same for ten years.

The Principal Chief Conservator of Forests (Head of Forest Force), Bangalore has revised the rates for 1:10 times the number of trees to felled vide letter cited at ref (6) above. Accordingly the cost of raising the compensatory plantation works charges is Rs. 40,95,000/- (Rs. Fourty Lakh Ninety Five Thousand only). The amount already paid is Rs 24,00,000/- (Twenty Four Lakh Only, excluding 1,60,000/-) and balance amount to be paid is Rs. 16,95,000/- (Sixteen Lakh Ninety Five Thousand Only).

Hence, you are hereby requested to pay an amount of . Rs. 16,95,000/- (Sixteen Lakh Ninety Five Thousand Only) to CAMPA account through FC web portal within 30 days.
