With reference to the above subject, this office vide Ref (1) letter dated 02-01-2021 has submitted the Compliance report to Government of Karnataka seeking Stage-II approval under Section 2 of Forest (Conservation) Act, 1980. Accordingly, the Government of Karnataka vide Ref (2) letter dated 20-01-2021 has forwarded the Compliance report to Government of India for seeking stage-II approval.

In response, Government of India vide Ref (3) has raised EDS query and informed that the location of the area identified for raising CA Plantation is not furnished in the Compliance report. The Government of Karnataka vide Ref (2) letter dated 26-02-2021 has communicated the same to this office.


Accordingly, the same has been communicated by this office vide Ref (1) letter dated 25-03-2021 to the field officers and they have been directed to submit the information.

In response, the Deputy Conservator of Forests, Mangaluru Division has identified an extent of 1.3 ha CA land at Sy No. 88 of Shantigodu (Kakve) village, Putturu Hobli in Narimogaru Reserved Forest and submitted the sketch copy, GPS coordinates of proposed CA land. Accordingly, the Chief Conservator of Forests, Mangaluru circle has agreed with the report of the Deputy Conservator of Forests, Mangaluru Division and has recommended the proposal.

In view of the above, it is requested to move the matter with the Government of India, Ministry of Environment, Forests & Climate Change, Integrated Regional Office Bengaluru to accord final approval (Stage-II) under the Forest (Conservation) Act, 1980 for diversion of 0.3542 ha of forest land in Sy No. 5, 106 and 165 of Shantigodu Village, KasabaHobli, Puttur Taluk, Dakshina Kannada District (Mangaluru Forest Division) for formation of Approach Road, Power Line, Intake to Jack well and Water Pipe Line in favour of the Executive Engineer, Minor Irrigation Department, Minor Irrigation Division, Mangaluru for a period of twenty (20) years (or the project life, whichever is earlier).
