Kind attention is invited to the reference 1<sup>st</sup> cited. In the above case user agency has remitted Rs. 116875/- (Rupees One lakh Sixteen Thousand Eight Hundred and Seventy Five Only) towards NPV for the Forest land proposed for diversion and the cost of raising plantation of ten times the number of tress to be felled in compliance to the conditions stipulated in the letter cited (1). The receipt slip for the amount remitted has already been submitted to that office wide reference (3) cited above.

The compliance report on the above subject is submitted here under.

- 1. The legal status of the forest land shall be kept unchanged.
- 2. The boundary of forest land diverted has been demarcated and survey stones were erected on the boundaries.

- 3. The user agency has already remitted an amount of Rs. 61000/- in the Corporation bank account number 150746110951723 towards the cost of raising plantation of ten times the number of trees to be felled.
- 4. The user agency has remitted an amount of Rs. 55875/- in the Corporation bank account number 150746110951723 towards the net present value for 0.0745 Ha of forest land to be diverted.
- 5. No additional amount of Net Present value to be remitted.
- 6. All the amount has been remitted in Corporation bank account number 150746110951723 of CAMPA.
- 7. There are no schedule tribes residing near the forest land to be diverted hence settlement of rights act is not applicable in this case.

- 9. Not applicable as the area is devoid of wildlife population
- 10. Necessary direction shall be issued to the user agency to not establish labour camps in the forest land to be diverted.
- 11. The user agency has been instructed to comply the direction
