



He stated that the comments / suggestions have been received from Prof. R. Sukumar, Member through E-Mail dated 08th February 2020 on the **Agenda Item No. 54.4.3 pertaining to use of 98.59 hectares of reserve forest land from proposed Saleki reserve forest for coal mining in Assam.**

Prof. R Sukumar suggested that the wording of the decision of 57th meeting of the Standing Committee be changed in the light of discussions.

After discussions, the Standing Committee decided to confirm the minutes.

54.4.3 Proposal for use of 98.59 ha of reserve forestland from Saleki proposed reserve forest which is a part of Dehing Patkai Elephant Reserve for Tikok OCP coal mining project by North-Eastern Coal Field, Coal India Limited, Assam State

The Member Secretary briefed the Standing Committee on the decision taken in the 57th meeting. He stated that the matter was considered by the Standing Committee in its 57th meeting which decided that the user agency should submit the following for further consideration:

- (D) The annual compliance certificate on the stipulated conditions should be submitted by the project proponent to the State Chief Wild Life Warden and an annual compliance certificate shall be submitted by the State Chief Wild Life Warden to Govt. of India.

58.4.4 Proposal for construction of Ujh multipurpose project, Jammu & Kashmir

The Member Secretary briefed the Standing Committee on the project for use of 4350 ha of land for the construction of 116m high concrete face rock fill dam across the river Ujh, a powerhouse of installed capacity 186 MW (3 x 62 MW) and powerhouse of 26 MW (1 x 2 MW + 1 x 24 MW) and a barrage 11.5 KM downstream of the dam. However, only a small portion of the right main canal (1200 m) would be constructed as underground canal in the ESZ on the north side of sanctuary. The State Chief Wild Life Warden has recommended the proposal without any conditions.

After discussions, the Standing Committee decided to recommend the proposal and suggested that the Chief Wild Life Warden should take measures for protection of wild life such as rhesus monkey, porcupine etc. in the area.

58.4.5 Proposal for 6-laning of Vadakkenchery - Thrissur section of NH-544, Kerala State

The Member Secretary briefed the Standing Committee on the use of 0.9984 ha forestland in four bits from Peechi Wildlife Sanctuary for widening of the existing NH-47 from 2-lane to 6-lane from Vadakkenchery to Mannuthy. He stated that the State Chief Wild Life Warden has recommended the proposal subject to the payment of Rs.4.00 crore by the user agency for the mitigation of human-animal conflict.

After discussions, the Standing Committee decided to recommend the proposal subject to the conditions that

- (1) The project proponent will comply with the condition imposed by the State Chief Wild Life Warden.
- (2) The annual compliance certificate on the stipulated condition should be submitted by the project proponent to the State Chief Wild Life Warden and an annual compliance certificate shall be submitted by the State Chief Wild Life Warden to Govt. of India.

58.4.6 Proposal for use of 3.05 ha of revenue land from Singhori Wildlife Sanctuary for upgradation of road from Chainpur to Bhartipur 5.05 KM cement concrete road, Madhya Pradesh State

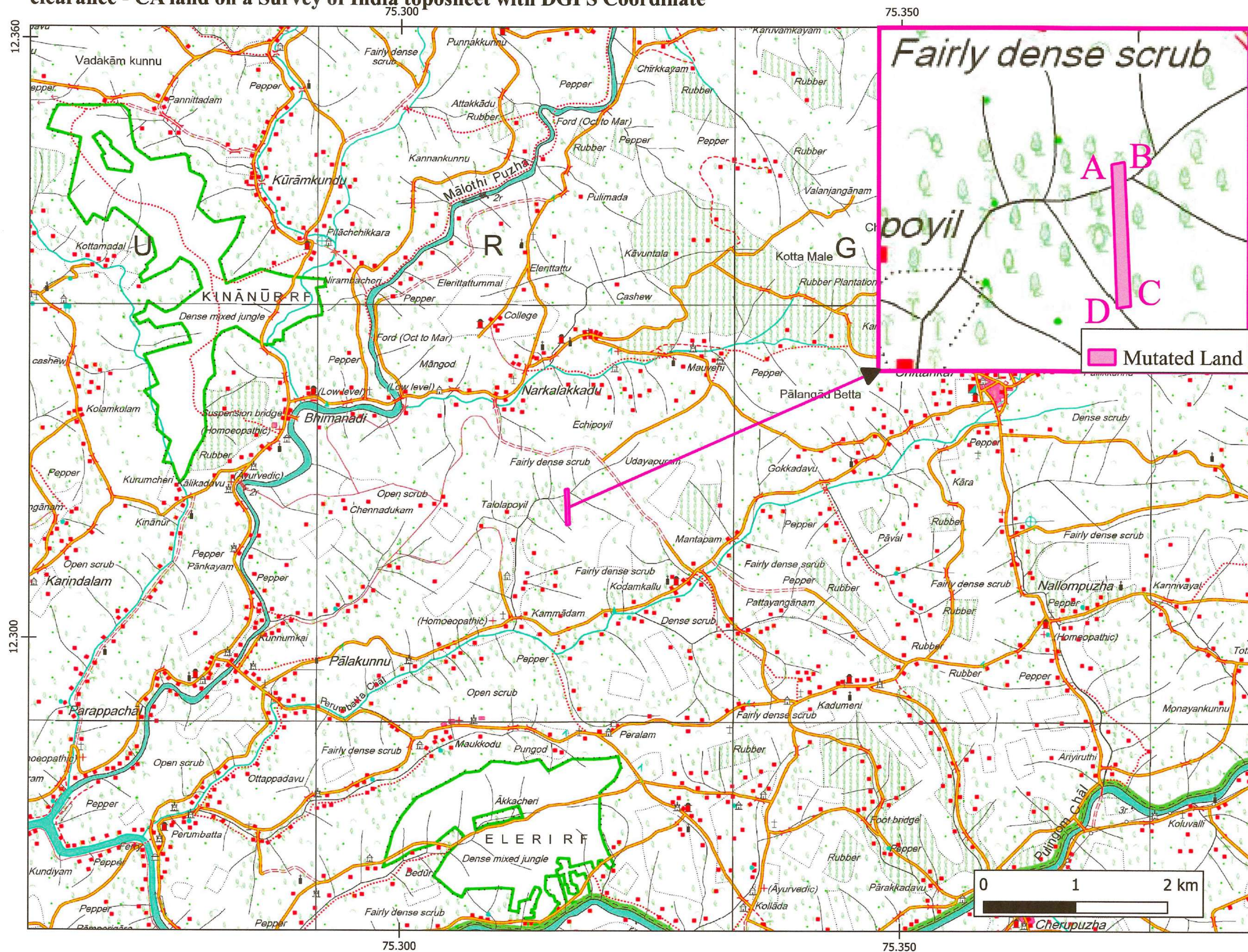

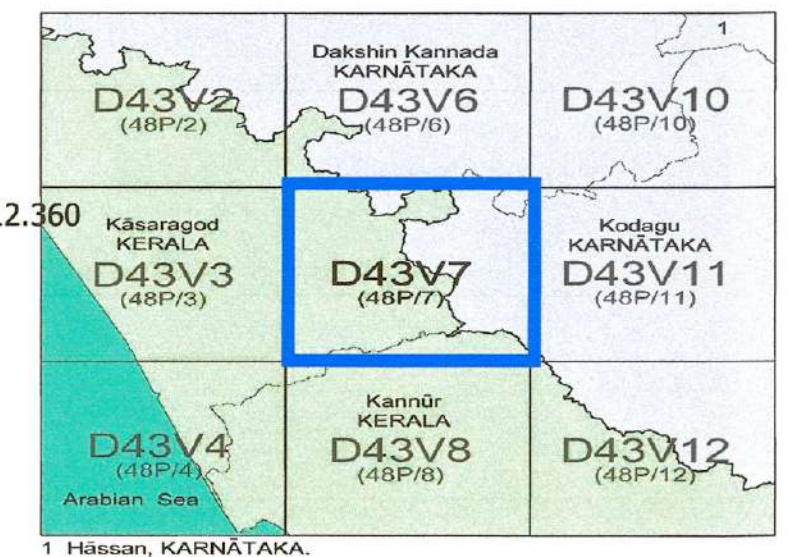

Order

1. the Kasaragod District Collector and Land Revenue Commissioner ,Kerala vide ref.(1) submitted not consider the proposal of transfer of 1.4318 hectares of land in Ambalathara village in Kasaragod district to the forest department for remedial afforestation to replace the forest land lost due to the development of Vadakancherry-Thrissur section national highway (forest land acquired for the construction of NH 544-Kutiran tunnel). According the District Collector vide ref.(2) informed that instead of initial proposal , a proposal for transfer of the land on which Kammadamkav is located in Bhimanadi village will be submitted and can be considered for CA land.
2. The land as per the revised proposal submitted by the Land Revenue Commissioner vide ref.(3) is found to be 1.4318 hectares of land belonging to resurvey No. 553 of Bhimanadi Village of Vellarikund Taluk , which have nature similar to forest land. The land was marked as A in the survey plan falls under the category of AW (Assessed Waste) as per village records and is having dense trees like forest. The said land does not belong to paddy field, wetland, water body, coast, protected monuments, development zones and restricted areas notified under CRZ/other categories.
3. The said land is recorded as Government property as per Fair Value Register and belongs to Kerala Land Bank under Land Code No. KRD - 140132001. Pattaya Bhoomi (Re survey No. 604/2 Garden Land with Road Access).Adjacent to the said land has a fair value of Rs.20,160/- per are. As the place is like a forest with dense trees, it is not possible to assess the improvements in it.

4. In this case, the District Collector had reported that 1.4318 hectares of land belonging to Reserve No. 553 in Bhimanadi village in Vellarikund taluk of Kasaragod district could be handed over to the Forest Department for remedial afforestation subject to the terms and conditions of transfer of land between the two service departments and the Land Revenue Commissionaire had recommended that the recommendation submitted earlier in the matter should not be considered. .
5. According to the guidelines issued by the Ministry of Environment, Forests and Climate Change by clarifying the Forest (Conservation) Act 1980 and Forest Conservation Rules, 2003, the land provided for remedial afforestation should be transferred in the name of the State Forest Department. But all government lands transferred between service departments should be retained in the revenue records as government expropriation to be covered by the Kerala Land Preservation Act and the steps in the Expropriation Rules, 1966 cannot be taken under any circumstances.
6. In this case, it was seen that the land should not be handed over to the Forest Department for remedial afforestation as per the terms of transfer of land between the two service departments, instead, as per the guidelines issued by the Ministry of Environment, Forests and Climate Change, the ownership of the land given for remedial afforestation should be transferred to the Forest Department in order to move the land on behalf of the State Forest Department.
7. Government has looked into the matter in detail and considered that 1.4318 hectares of AW category land belonging to bheemanadi village in vellarikundu taluk in Kasaragod district is to replace in lieu to forest land lost due to National highway development in Vadakancherry Thrissur section (construction of NH 544-Kutiran tunnel), handing over the ownership to the Kerala state Forest Department for afforestation as per the order/ guidelines issued by MOEF & CC..

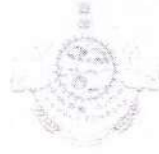

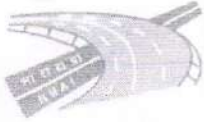

2. Accordingly, this office has remitted the following amount:-



In view of the above, it is requested to accord permission to NHAI / Concessionaire M/s.Thrissur Expressway Limited for cutting the trees.Also permission may please be granted for entry of the machinery / vehicles to transport the cut-down trees to forest depot location as mentioned in the reference 1st cited.



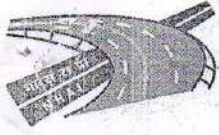


