Proposal for seeking prior approval of the Central Government under section 2 (1) (ii) of the Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 for diversion of 315.74 ha forest land under section 2 (1) (ii) of the Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 for Renovation of Asolamendha Irrigation Project in Division Bramhapuri, Central Chanda and Chandrapur Forest Division, Saoli, Mul and Pombhurna talukas of Chandrapur District in the State of Maharashtra (Online No.FP/MH/IRRIG/39591/2019) – regarding.

With reference to the above mentioned subject, the Government of India has decided to sanction for diversion of 315.74 Ha. of Forest land subject to fulfillment of some conditions. The conditions mentioned in the above referred letter have been fulfilled by the User authority as under.
