

Based on recommendations of the EAC, the Ministry of Environment, Forest and Climate Change hereby accords approval for revalidation of the existing environmental clearance to the clearance dated 2nd February, 2006, and grant of environmental clearance to the expansion of Pauni-II Opencast Coal Mining project from 0.60 MTPA to 3.25 MTPA of M/s Western Coalfields Ltd In mine lease area of 1095.52 ha located in village Sakhri, Tehsil Rajura, District Chandrapur (Maharashtra), for a period of one year, under the provisions of the Environment Impact Assessment Notification, 2006 and subsequent amendments/circulars thereto, subject to the compliance of the terms & conditions and environmental safeguards as under:-

(i) The project proponent shall collect and analyze one season data for environmental parameters and submit for consideration of the EAC before 31rd December, 2019.

(ii) The project proponent shall obtain Consent to establish from the State Pollution Control Boards for the proposed peak capacity of 3.25 MTPA prior to commencement of the increased production.

(iii) Transportation of coal from face to Coal heap shall be carried out by truck. Further, coal transportation from Coal heap to Coal Handling Plant shall be through covered trucks.

(iv) To control the production of dust at source, the crusher and in-pit belt conveyors shall be provided with mist type sprinklers.

(v) Mitigating measures shall be undertaken to control dust and other fugitive emissions all along the roads by providing sufficient water sprinklers. Adequate corrective measures shall be undertaken to control dust emissions, which would include mechanized sweeping, water sprinkling/mist spraying on haul roads and loading sites, long range misting/fogging arrangement, wind barrier wall and vertical greenery system, green belt, dust suppression arrangement at railway siding, etc.

(vi) The company shall obtain approval of CGWA for use of groundwater for mining operations at its enhanced capacity of 3 25 MTPA.

(vii) Continuous monitoring of occupational safety and other health hazards, and the corrective actions need to be ensured.

(viii) Persons of nearby villages shall be given training on livelihood and skill development to make them employable.

(ix) To ensure health and welfare of nearby villages, regular medical camps shall be organized at least once in six months.

(x) Thick green belt of adequate width at the final boundary in the down wind direction of the project site shall be developed to mitigate/check the dust pollution.

(xi) Efforts shall be made for utilizing alternate sources of surface water, abandoned mines or else whatsoever and thus minimizing the dependability on a single source.

(xii) A third party assessment of EC compliance shall be undertaken once in three years through agency like ICFRI /NEERI/IIT or any other expert agency identified by the Ministry.

4.1 The grant of environmental clearance is further subject to compliance of the generic conditions as under:

(a) Mining

(i) Mining shall be carried out under strict adherence to provisions of the Mines Act 1952 and subordinate legislations made there-under as applicable.

(ii) No change in mining mothed, calendar programme and scope of work shall be made without obtaining prior approval of the Ministry of Environment, Forest and Climate Change.

(iii) Mining shall be carried out as per the approved mining plan including Mine Closure Plan, abiding by mining laws related to coal mining and the relevant circulars issued by Directorate General Mines Safety (DGMS).

(iv) No mining shall be carried out in forest land without obtaining Forestry Clearance as per Forest (Conservation) Act, 1980 and also adhering to The Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2008 read with provisions of Indian Forest Act, 1927.

(b) Land reclamation and water conservation

0

(i) Digital Survey of entire lease hold area/core zone using Satellite Remote Sensing survey shall be carried out at least once in three years for monitoring land use pattern and report in 1:50.000 scale shall be submitted to Ministry of Environment, Forest and Climate Change/Regional Office (RO).

(ii) The surface drainage plan including surface water conservation plan for the area of influence affected by the said mining operations, considering the presence of river/rivulet/pond/lake etc, shall be prepared and implemented by the project proponent. The surface drainage plan and/or any diversion of natural water courses shall be as per the approved Mining Plan/EIA/EMP report and with due approval of the concerned State/Gol Authority. The construction of embankment to prevent any danger against inrush of surface water into the mine should be as per the approved Mining Plan and as per the permission of DGMS.

(iii) The final mine void depth should preferably be as per the approved Mine Closure Plan, and in case it exceeds 40 m, adequate engineering interventions shall be provided for sustenance of aquatic life therein. The remaining area shall be backfilled and covered with thick and alive top soil. Post-mining land be rendered usable for agricultural/forestry purposes and shall be handed over to the respective state government as specified in the guidelines for Preparation of Mine Closure Plan issued by the Ministry of Coal dated 27th August, 2009 and subsequent amendments.

(iv) The entire excavated area, backfilling, external OB dumping (including top soil) and afforestation plan shall be in conformity with the "during mining"/"post mining" land-use pattern, which is an integral part of the approved Mining Plan and the EIA/EMP submitted to this Ministry. Progressive compliance status vis-a-vis the post mining land use pattern shall be submitted to the Ministry of Environment, Forest and Climate Change/Regional Office on six monthly basis.

(v) The top soil shall temporarily be stored at earmarked site(s) only and shall not be kept unutilized for long. The top soil shall be used for land reolamation and plantation purposes. Active OB dumps shall be stabilised with native grass species to prevent erosion and surface run off. The other overburden dumps shall be vegetated with native flora species. The excavated area shall be backfilled and afforested in line with the approved Mine Closure Plan. Monitoring and management of rehabilitated areas shall continue until the vegetation becomes self-sustaining. Compliance status shall be submitted to the Ministry of Environment, Forest and Climate Change/ Regional Office on six monthly basis.

(i) Transportation of coal, to the extent permitted by road, shall be carried out by covered trucks/conveyors. Effective control measures such as regular water/mist eprinkling/rain gun etc shall be carried out in critical areas prone to air pollution (with higher values of PM₁₀/PM_{2.5}) such as haul road, loading/unloading and transfer points. Fugitive dust emissions from all sources shall be controlled regularly. It shall be ensured that the Ambient Air Quality parameters conform to the norms prescribed by the Central/State Pollution Control Board.

(ii) Groenbolt consisting of 3-tior plantation of width not less than 7.5 m shall be developed all along the mine lesse area in a phased manner. The green belt comprising a mix of native species shall be developed all along the major approach/ coal transportation reads.

(III) The transportation of coal shall be carried out as por the provisions and route proposed in the approved Mining Plan. Transportation of the coal through the existing road passing through any village shall be avoided. In case, it is proposed to construct a 'bypass' road, it should be so constructed so that the impact of sound, dust and accidents could be appropriately mitigated.

(iv) Vehicular emissions shall be kept under control and regularly monitored. All the vehicles ongeged in mining and allied activities shall operate only after obtaining 'PUC' certificate from the authorized pollution testing centres.

(v) Coal slock plic/crusher/focder and breaker material transfer points shall invariably be provided with dust suppression system. Belt-conveyors shall be fully covered to avoid air borne dust. Side cladding all along the conveyor gantry should be made to avoid air borne dust. Drills shall be wet operated or fitted with dust extractors.

(vi) Coal handling plant shall be operated with effective control measures viz. bag filtors/water or mist sprinkling system etc to check fugitive emissions from crushing operations, conveyor system, transfer points, etc.

(vii) Ground water, excluding mine water, shall not be used for mining operations. Rainwater harvesting shall be implemented for conservation and augmentation of ground water resources.

(viii) Catch/garland drains and siltation ponds of appropriate size shall be constructed around the mine working, coal heaps & OB dumps to prevent run off of water and flow of sediments directly into the river and water bodies. Further, dump material shall be properly consolidated/ compacted and accumulation of water over dumps shall be avoided by providing adequate channels for flow of silt into the drains. The drains/ ponds so constructed shall be regularly de-silted particularly before onset of monsoon and maintained properly. Sump capacity should provide adequate relention period to allow proper settling of silt material. The water so collected in the sump shall be utilised for dust suppression measures and green belt development. Dimension of the retaining wall constructed, if any, at the toe of the OB dumps within the mine to check run-off and siltation should be based on the rainfall data. The plantation of native spocies to be made between toe of the dump and adjacent field/habitation/water bodies.

(ix) Industrial wasto water generated from CHP, workshop and other waste water, shall be properly collected and treated so as to conform to the standards prescribed under the Environment (Protection) Act, 1986 and the Rules made there under, and as amended from time to time. Oil and grease trap shall be installed and maintained fully functional with effluents

discharge adhering to the norms. Sowage treatment plant of adequate capacity shall be installed for treatment of domestic waste.

(x) Adequate groundwater recharge measures shall be taken up for augmentation of ground water. The project authorities shall meet water requirement of nearby village(e) in uses the village wells go dry due to dewatering of mine.

(d) Illumination, noise & vibration

(i) Adequate illumination shall be ensured in all mine locations (as per DGMO etundards) and monitored weakly. The report on the same shall be submitted to this ministry & its RO on six-monthly basis.

(ii) Adequate measures shall be taken for control of noise levels below 06 dB(A) in the work environment. Workers engaged in blasting and drilling operations, operation of HEMM, etu shall be provided with personal protective equipments (PPE) like ear plugs/muffs in conformity with the prescribed norms and guidelines in this regard. Adequate awareness programme for users to be conducted. Progress in usage of such accessories to be monitored.

(iii) Controlled blasting techniques shall be practiced in order to miligate ground vibrations and fly rocks as per the guidelines prescribed by the DOMS.

(iv) The noise level survey shall be carried out as per the prescribed guidelines to assess noise exposure of the workman at vulnerable points in the mine premises, and report in this regard shall be submitted to the Ministry/RO on six-monthly basis.

(e) Occupational health & safety

(i) The project proponent shall undertake occupational health survey for initial and periodical medical examination of the workers engaged in the project and maintain records accordingly as per the provisions of the Mines Rules, 1955 and DOMS circulars. Besides regular periodic health check-up, 20% of the workers identified from workforce engaged in colive mining operations shall be subjected to health check-up for occupational diseases and hearing impairment, if any.

(ii) Personnel (including outsourcing employaes) working in dusty areas shall wear protective respiratory devices and shall also be provided with adequate training and information on safety and health aspects.

(iii) Skill training as per sufety norms specified by DGMS shall be provided to all workmen including the outsourcing employees to ensure high addety standards in mines.

(f) Ecosystem and biodiversity conservation

(i) The project proponent shall take all precautionary measures during mining operation for conservation and protection of endungered flora/fauna, if any, spotled/reported in the study area. The Action plan in this regard, if any, shall be propared and implemented in consultation with the State Forest and Wildlife Department.

(g) Public hearing, R&R and CSR

(i) Implementation of the action plan on the lastics mixed during the public hearing shall be ensured. The project proponent shull undertake all the tasks/measures as per the action plan mage 7 of 11

submitted with budgetary provisions during the public hearing. Land oustees shall be compensated as per the norms laid down in the R&R policy of the company/State Government/Central Government, as applicable.

(ii) The project proponent shall ensure the expenditure towards socio-economic development in and around the mine, in every financial year as per the Corporate Social Responsibility Policy as per the provisions under Section 135 of the Companies Act, 2013

(iii) The project proponent shall follow the mitigation measures provided in this Ministry's OM No Z-11013/5712C14-IA.I1 (M) dated 29th October, 2014, titled 'Impact of mining activities on habitations-issues related to the mining projects wherein habitations and villages are the part of mine lease areas or habitations and villages are surrounded by the mine lease area'.

(iv) The project proponent shall make necessary alternative arrangements, if grazing land is involved in core zone, in consultation with the State government to provide alternate areas for livestock grazing, if any. In this context, the project proponent shall implement the directions of Hon'ble Supreme Court with regard to acquiring grazing land.

(h) Corporate environment responsibility

(i) The Company shall have a well laid down environment policy duly approved by Board of Directors. The environment policy should prescribe for standard operating procedures to have proper checks and balances and to bring into focus any infringements/deviation/violation of the environmental or forest norms/conditions. Also, the company shall have a defined system of reporting of non-compliances/violations of environmental norms to the Board of Directors and/or shareholders/stakeholders.

(ii) The project proponent shall comply with the provisions contained in this Ministry's OM dated 1st May, 2018, as applicable, regarding Corporate Environment Responsibility.

(iii) The hierarchical system or Administrative Order of the company to deal with environmental issues and for ensuring compliance with the environmental clearance conditions should be displayed on website of the Company.

(iv) A separate environmental management cell both at the project and company headquarter level, with suitable qualified personnel shall be set-up under the control of a Senior Executive, who will report directly to the Head of the Organization.

(v) Action plan for Implementing EMP and environmental conditions shall be prepared and shall be duly approved by competent authority. The year wise funds earmarked for environmental protection measures shall be kept in separate account and not to be diverted for any other purpose. Year wise progress of implementation of action plan shall be reported to the Ministry/Regional Office along with the Six Monthly Compliance Report.

(vi) Self environmental audit shall be conducted annually. Every three years third party environmental audit shall be carried out.

(i) Statutory Obligations

(i) The environmental clearance shall be subject to orders of Hon'ble Supreme Court of India, Hon'ble High Court, NGT and any other Court of Law from time to time, and as applicable to the project.

 $(|v\rangle)$ The project proponent shall obtain the necessary permission from the Central Ground Water Authority (CGWA).

(i) Monitoring of project

(1) Adequate ambient air quality monitoring stations shall be established in the core zone as well as in the buffer zone for monitoring of pollutants, namely PM10, PM25, SO2 and NOx. Location of the stations shall be decided based on the meleorological data, topographical features and environmentally and ecologically sensitive targets in consultation with the State Pollution Control Board. Online ambient air quality monitoring stations may also be installed in addition to the regular monitoring stations as per the requirement and/or in concultation with tho SPCB. Monitoring of heavy metals such as Hg, As, NI, Cd, Cr, etc to be carried out at least once in six months.

The Ambient Air Quality monitoring in the core zone shall be carried out to ensure the (ii) Coal Industry Standards notified vide GSR 742 (E) dated 25.9.2000 and as amended from time to time by the Central Pollution Control Board. Data on ambient air quality and heavy metals such as Hg, As, Ni, Cd, Cr and other monitoring data shall be regularly reported to the Ministry/Regional Office and to the CPCB/SPCB.

The effluent discharge (mine waste water, workshop effluent) shall be monitored in terms of the parameters notified under the Coal Industry Standards vide GSR 742 (E) dated 25.9.2000 and as amended from time to time by the Central Pollution Control Board.

The monitoring data shall be uploaded on the company's website and displayed at the (iv) project site at a suitable location. The circular No. J-20012/1/2006-IA.11 (M) dated 27.05.2009 issued by Ministry of Environment, Forest and Climate Change shall also be referred in this regard for its compliance.

Regular monitoring of ground water level and quality shall be carried out in and around (V) the mine lease area by establishing a network of existing wells and constructing new piezometers during the mining operations. The monitoring of ground water levels shall be carried out four times a year i.e. pre-monsoon, monsoon, post-monsoon and winter. The ground water quality shall be monitored once a year, and the data thus collected shall be sent regularly to Ministry of Environment, Forest and Climate Change/Regional Office.

(iv) The EC shall be uploaded on the company's website. The compliance status of the stipulated EC conditions shall also be uploaded by the project authorities on their website and updated at least once every six months so as to bring the same in public domain.

(v) The project authorities shall advertise at least in two local newspapers widely circulated, one of which shall be in the vernacular language of the locality concernec, within 7 days of the issue of this clearance, informing that the project has been accorded environmental clearance and a copy of the same is available with the State Pollution Control Board and also at website of the Ministry.

(vi) The environmental stalement for each financial year ending 31 March in Form-V is mandated to be submitted by the project proponent for the concerned State Pollution Control Board as prescribed under the Environment (Protection) Rules, 1986, as amended subsequently, shall also be uploaded on the Company's website along with the status of compliance of EC conditions and shall be sent to the respective Regional Offices of the MoEF&CC by e-mail. 7. Any appeal against this environmental clearance shall lie with the National Green Tribunal, if preferred, within a period of 30 days as prescribed under Section 16 of the National Green Tribunal Act, 2010.

Land Surrender Plan for Forest Land 12.07 Ha

Mining is a large-scale activity which involves huge quantum of land area. It utilizes heavy machineries like Dumpers, Excavators, Drilling Machines etc. The location of coal reserve is site specific, which makes acquisition and diversion of the forest land is necessary for coal mining. Diversion of forest land is taken only if it is unavoidable by the User Agency. The diverted forest lands will be backfilled, biologically reclaimed as per the approved mining plan and mine closure plan. Then, it will be surrendered back to the Forest Department at the end of completion of mining activities.

The Forest land measuring 12.07 Ha was acquired by the WCL u/s 9(i) of CBA (A&D) Act 1957 vide S.O. no 2276(E) dated 18.08.2015. The existing Sakhari-Irawati (Pouni III) Opencast Mine Project is being worked in Pauni Extension Block. The operation of existing mine has been planned in two quarries i.e. Quarry-I (Western quarry) and Quarry-II (Eastern quarry). Considering the practical difficulties in river diversion & village shifting, it is proposed to first work quarry-I. Quarry No: II would be worked after quarry-I gets exhausted. Presently, mine working is being done in Quarry-II and it has reached upto 60m RL (about 120m depth). Quarry-II involves diversion of Sakhari and Lande Nallah, which has been completed. The Forest Land 12.07 Ha was falling in the western side of the Quarry II.

As per the sequence of dumping and stage-wise plan, backfilling of void of the quarry will be initiated at the end of 6^{th} year of mine life. During this period 1.5 MM³ quantity of internal dumping is proposed. This is a continuous process in which 80.73 MM³ quantity of internal dumping will be done at the end of 14^{th} Year and End of Mine Life.

As per the latest Project Report of approved by the Coal India Limited Board in 2018, the mine life is 14 years. Hence, as per the mining plan, this 12.07 Ha Forest Land will be surrendered back to Forest Department after 14th Year and as per the Mine Closure Plan. If the forest land is handed over to WCL after Stage II forest clearance and necessary formalities within the year 2025, it may be surrendered after end of 14th Year of mine life.



Introduction

The Sakhari-Irawati Pauni III OC mine is an operating mine of Ballarpur Area, WCL located in the extreme western part of Rationalized Pauni Combined Geological block of Wardha Valley Coalfield. The area falls in the Rajura tehsil of Chandrapur district of Maharashtra State. The Chandrapur district township is located at the distance of about 25 km from the block . Delhi-Madras Grand Chord Railway line passes through Ballarpur township which is located in the NE of the block at a distance of about 10 km. Ballarshah Railway Station is located in the NE at about 10 km from the area. The area of Sakhari-Irawati Pauni III OC block is bounded by latitudes N 190 48' 19" and 190 49' 27" and Longitude E 790 13' 48" and 790 16' 13". The block is covered in the survey of India Toposheet No.- 55 M/5 .

1. Objectives

A)To conserve and reuse nutrient-rich topsoil for ecological restoration and rehabilitation.

C)Construction of green belts and external dump plantations.

D)Afforestation programs under the Mine Closure Plan.

Sir.

I am directed to refer to WCL's letter No.WCL/MP(L/R)/MK/750 dated 9.10.2019 and WCL's letter No.WCL/GM/L&R)/AK/491 dated 16.05.2018 on the above mentioned subject. The requisite clarification of Ministry of Coal in the matter is as under:-

By virtue of the provisions of section 10 and 11 of the Coal Bearing Areas (Acquisition and Development) Act, 1957, the land or the rights in or over the land acquired under the Act vest absolutely with the Central Government or the nominee, that is, a Government Company. The land gets vested in the Central Government on the publication of notification under Section 9 and thereafter in the Govt. Company on the publication of declaration under Section 11(1) of the ibid Act. Accordingly, since the land acquired under the Act vests absolutely in the Government Company, there is no necessity for execution of Mining Lease with the State Government. The issue of requirement of Mining Lease in case of lands acquired under CBA Act has been settled by Hon'ble Supreme Court in Bharat Coking Coal Ltd Vs. State of Bihar [1987 (Suppl) SCC 394], wherein the Court observed that "once the acquisition is made under the Coal Bearing Areas (Acquisition and Development) Act, 1957, requisite declaration was issued by the Central Government, it was not open to the State Government to grant Lease as the land vests in the Central Government". The said findings of the Hon'ble Supreme Court has also been followed by the Division bench of High Court of MP in Western Coalfields Limited and Ors vs State of MP and Anr (AIR 2007 MP 75).

Since the subject land was acquired under the CBA(A&D) Act, 1957 and vests 2. absolutely in the Government Company, neither the execution of mining lease with the State Government is required as per statute nor there is any necessity as it was not open to State Government to grant lease and therefore provisions of MMDR Act, 1957

Assam:

along with the Mineral Concessions Rules, 1960 does not apply over the land/rights acquired under CBA(A&D) Act, 1957. Therefore the land in respect of Tawa-II UG, Satpura-II UG, Shobhapur UG mine of Pathakhera area and similar acquisition of WCL acquired under Section 9(1) of CBA (A&D) Act, 1957, the provisions of MMDR Act, 1957 and MC Rules, 1960 does not apply.


