



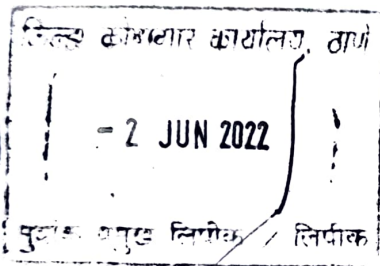

४. शासनाचे घोरणाप्रमाणे जेथे रस्त्याच्या मध्यापासून कमीत कमी १५ मीटर अंतरावर ऑप्टिकल फायबर केबल टाकणे शक्य नसेल तेथे तेवढ्या लांबीत ऑप्टिकल फायबर केबल टाकण्यास शासन सा. बां. विभाग पत्र क्र. संकीर्ण - २००१/ प्र.क्र. १८ /रस्ते-७ दि. २३.१.२००१ अन्वये तात्पुरत्या स्वरूपात परवानगी देण्यात येत आहे व सा. बां. विभाग पत्र क्र. विपआ -२०१८/

- प्र.क्र. ३८७ /रस्ते-७ दि. १६.२.२०१८ अन्वये सूचनानुसार उद्योजकास तेवढ्या लांबीत लवकरात लवकर स्वखर्चाने स्वताची पर्यायी व्यवस्था करून केबल १५ मीटर अंतरावर टाकणे आवश्यक आहे. या प्रकरणी शासन कोणतीही नुकसान भरपाई संबंधितास देणार नाही.
५. ऑप्टिकल फायबर केबल ज्या ठिकाणी रस्त्याला छेदून टाकण्याचे प्रस्तावित आहे, त्या ठिकाणी Horizontal drilling करून Conduit pipe टाकून केबल टाकण्यात यावेत व ज्या ठिकाणी Horizontal drilling शक्य नाही अशा ठिकाणी खोदाई करून Conduit pipe (Specially Built) चे बांधकाम करून त्या मधुन केबल टाकण्यात यावेत.
 ६. रस्त्याखालून केबल / पाईपलाईन घेवून जाण्याकरीता टाकण्यात येणारे कॅसिंग पाईप (Conduit pipe / Casing Pipe) स्टील, कास्ट आयर्न किंवा आर.सी.सी. प्रकारचे व आवश्यक क्षमतेचे आणि केबल/ पाईप टाकता व काढता येतील अशा आकाराचे असणे गरजेचे आहे.
 ७. रस्त्याच्या खालून केबल / पाईप इ. टाकण्यासाठी किंवा (Conduit pipe / Casing Pipe) साठी चर खोदण्यात आले तर रस्त्याचा पृष्ठभाग व त्याखालील पूर्ण जाडीत रस्त्याच्या थरांचे बांधकाम खात्याच्या विनिर्देश प्रमाणे व कार्यकारी अभियंता यांचे देखरेखी खाली करून रस्ता पुर्ववत करावा लागेल.

 ९. केबल डक्टसाठी खोदकाम करताना उपयुक्त असे मुरूम, खडी, दगड यासारखे गौण खनिजावर सार्वजनिक बांधकाम विभागाची मालकी असेल, असे गौण खनिज योग्य प्रकारे साठवून ते कार्यकारी अभियंता यांचेकडे सुपूर्द करण्याची जबाबदारी संबंधीत अभिकर्ता कंपनीची राहिल.
 १०. खोदकाम चालू असताना रस्त्याच्या कडेची झाडे तोडणे अनिवार्य असल्यास अभिकर्ता कंपनीने संबंधित सक्षम प्राधिकरणाची पूर्व परवानगी मिळवावी. तसेच पर्यावरणाचा समतोल राखण्यासाठी उपलब्ध जागेवर पुन्हा वृक्षारोपण करणे कंपनीस बंधनकारक राहिल.
 ११. महाराष्ट्र सरकार व केंद्रीय जल भुतल परिवहन मंत्रालयाने नविन नियम, अटी व शर्ती प्रस्तुत केल्यास त्या अभिकर्ता कंपनीस बंधनकारक राहतील. तसेच भविष्यात रस्ता रुंदीकरणासाठी केबल टाकावयाची झाल्यास त्याचा खर्च संबंधित कंपनीने करावा.
 १२. कंपनीद्वारे ऑप्टिकल फायबर केबल टाकण्याचे काम सुरू करण्यापूर्वी संबंधित कंपनीने सार्वजनिक बांधकाम खात्याशी संपर्क साधावा व संबंधित क्षेत्राच्या क्षेत्रीय अधिका-यांच्या मार्गदर्शनाखाली व देखरेखीखाली काम सुरू करावयाचे आहे.
 १३. रस्त्याखालून ओ.एफ.सी. लाईन टाकण्याचे कामास सुरूवात करणेपूर्वी कामाच्या ठिकाणापासून दोन्ही दिशेला १०० मीटर अंतरावर सावधानतेच्या इशाराचे फलक रिकलेक्टीव स्ट्रीपचा वापर करून लावण्यात यावेत. तसेच रात्रीच्या वेळी काम सुरू अथवा अपूर्ण राहिल्यास माहितगार तंत्रज्ञांसह रात्रभर तेवत राहणारा लाल प्रकाश झोताचा दिवा लावण्याची वा तत्सम व्यवस्था कंपनीने करावी.

१४. रस्त्याच्या पृष्ठभाग केबल टाकणेसाठी रस्त्याच्या पृष्ठभाग / याहपट्टी खोदली असता मोकळा होऊन पोकळी निर्माण झालेल्या रस्त्या भागामध्ये संबंधित कंपनीने रयग्यर्चाने सिमेंट क्रॉक्रीट अथवा तत्सम सर्वांतर पातळीने बांधकाम साहित्याने भराय करून रस्त्याच्या पृष्ठभागाची Rigidity कायम ठेवायची आहे.
१५. प्रस्तावात केलेल्या कामाव्यतिरिक्त इतर काही जास्तीचे काम करावयाचे झाल्यास सा.बां.खात्याची पूर्त भरवानगी घेणे कंपनीस बांधकामकारक आहे.
१६. ऑप्टिकल फायबर केबल टाकणेचे काम चालू असताना एखादा अपघात घडल्यास त्याची संपूर्ण जबाबदारी संबंधित कंपनीची राहिल.
१७. ऑप्टिकल फायबर केबल टाकणेचे काम पूर्ण झाल्यानंतर कामाच्या ठिकाणी सा.बां.खात्याच्या मालकीच्या जागेत संबंधित कंपनीच्या मालकीचे किंवा त्यांच्या संबंधित ठेकेदारांच्या मालकीचे कोणतेही अतिरिक्त साहित्य,मशिनरी अथवा शेड राहणार नाही याची दक्षता सदर कंपनीने घ्यावी.
१८. कंपनीच्या मालमत्तेचे हानीपासून संरक्षण करण्याची हमी शासन देत नाही.
१९. सदर काम चालू करण्यापूर्वी संबंधित कंपनीने रस्त्याचा काटछेद नकाशा, पृष्ठभाग खोदण्यासाठी वापरात येणारी मशिनरी व तिची पद्धत तसेच खोदाईच्या कामासाठी व प्रत्यक्ष काम पूर्ण होण्यासाठी लागणारा कालावधी इत्यादीबाबतचा सविस्तर अहवाल सा.बां.खात्याचे सक्षम अधिकारी यांना द्यावा.
२०. सदरहू कंपनी स्वतःच्या खर्चाने रस्त्याखाली घातलेल्या ऑप्टिकल फायबर केबल देखभाल व दुरुस्ती करून ती योग्य स्थितीत ठेवतील आणि रस्त्याचे व रस्त्याच्या बाजूकडील जमिनीच्या पृष्ठभागाचे किंवा शासनाच्या सा.बां.खात्याच्या मालमत्तेचे जे काही नुकसान होईल ते कार्यकारी अभियंता,सा.बां.विभाग किंवा त्यांचे प्रतिनिधी यांचे संपूर्णतः समाधान होईल अशाप्रकारे पुर्वत दुरुस्ती करून व्यवस्थित करून द्यावे लागेल.
२१. करारातील कोणत्याही शर्तीचे संबंधित कंपनीने पालन न केल्यास तीन महिने आगाऊ दिलेल्या नोटीसची मुदत संपल्यावर जमिनीचीखालील केबल काढून टाकण्याची कार्यकारी अभियंता सा.बां.विभाग यांना मोकळीक असेल, आणि कार्यकारी अभियंता यांचेद्वारे करण्यात आलेल्या खर्चास संबंधित कंपनी जबाबदार असेल.
२२. सदरहू ऑप्टिकल फायबर केबल टाकणेचे काम सुरू करण्यापूर्वी केबल टाकण्यासाठी खोदण्यात आलेली रस्त्याची जमीन खचणे इ. सारखी भविष्यात घटना घडल्यास ती जमीन व रस्त्याचा पृष्ठभाग सुस्थितीत पुर्वत आणण्यासाठी भरावयाची रक्कम व अनामत रक्कम कार्यकारी अभियंता कार्यालयात जमा करावयाची आहे.
२३. सदर रस्त्याच्या १५ मीटर हद्दीपलीकडे शेतकरी, संस्था,इतरखाजगी कंपनी व इतर खात्याची अथवा इतर कोणाच्या हक्कांची जमीन येत असल्यास केबल टाकण्याकरिता त्यांची स्वतंत्र परवानगी घेणे आवश्यक आहे व त्याच्या सहमतीने केबल टाकण्याचे काम करण्यात यावे.अन्यथा काही तक्रारी उद्भवलेस सा.बा.विभाग जबाबदार राहणार नाही.
२४. सदरहू कामास सुरुवात करण्यापूर्वी सा. बां. खात्याकडून घालून दिलेल्या सर्व अटी मान्य असल्याचा कायम स्वरुपी करारनामा रु. ५००/- किंमतीच्या मुद्रांक शुल्कावर (दस्तावेज) तयार करून त्यावर कार्यकारी अभियंता यांचे स्वाक्षरीसह मंजूर करून द्यावा.

१५. केबल खोदाई व केबल टाकण्याचे काम टप्पाटप्प्याने पूर्ण करणे आहे. सुमारे २०० मीटर अंतरापर्यंत खोदाई पूर्ण झाल्यावर केबल टाकणे व खोदाई बुजवून त्यावर दबाई करणे ही बाब करणे जरूरी आहे.
१६. सदरची परवानगी ही मुख्य अभियंता सा.बा.प्रादेशिक विभाग पुणे यांचे बतीने संबंधित कार्यकारी अभियंता सा.बा.विभाग यांनी रु. ५००/- किंमतीच्या स्टॅम्पपेपर कायदेशीर करारनामा ऑप्टिकल फायबर केबल कंपनीसाठी करून दिल्यानंतर त्यातील अटी व शर्तीस अधीन राहून असेल.
१७. महाराष्ट्र सरकार व केंद्रीय जलभुतल परिवहन मंत्रालयाने भविष्यात नविन नियम, अटी / शर्ती प्रस्तुत केल्यास त्या अनुज्ञप्ती धारक कंपनीस बंधनकारक राहतील.
१८. पुल/मो-या /स्लॅब ब्रेन असलेल्या भागात ऑप्टिकल फायबर केबल टाकण्याची व्यवस्था मंजूर करून घ्यावी व ऑप्टिकल फायबर केबल पुलाच्या पॅरापेटच्या / रेलिंगच्या बाहेरच्या बाजूने लोखंडी क्लॅम्पच्या सहाय्याने टाकण्यात यावी.
१९. रस्ता रुंदीकरणाच्या वेळी रुंदीकरणाच्या वाढीव हद्दीपलिकडे सा. बां. विभागाने दिलेल्या सूचनांप्रमाणे कंपनीस केबल स्वखर्चाने हलवावी लागेल. या करिता सा. बां. विभागाकडून आगाऊ तीस दिवसांची नोटीस दिली जाईल. नोटीस दिल्यानंतर तीस दिवसांच्या आत ही केबल काढून न टाकल्यास सा. बां. विभागाकडून केबल काढून टाकण्यात येईल. अथवा रस्ता रुंदीकरणाचे काम सुरु करण्यात येईल. प्रवर्तकास नविन केबल रस्त्याच्या वाढीव हद्दीपलिकडे सा. बां. विभागाच्या पूर्व परवानगीने स्वखर्चाने टाकावी लागेल.
२०. ज्या ठिकाणी खोदकाम करावयाचे आहे. तेथील अस्तित्वातील भारत संचार निगम लि. व इतर खाजगी केबल, विद्युत केबल पाईप लाईन इत्यादींचे नुकसान झाल्यास त्याची नुकसान भरपाई कंपनीने करावयाची आहे. होणा-या नुकसान भरपाईस हे खाते जबाबदार राहणार नाही याची संबंधितांनी नोंद घेणे आवश्यक आहे.
२१. घाटामधील भागात ऑप्टिकल फायबर केबलची खोदाई करताना शक्यतो त्याभागात पुर्बी एखाद्या कंपनीची केबल खोदाई झाली असल्यास त्या खोदाईच्या चरामधुनच नवीन केबल टाकण्याबाबत क्षेत्रीय अधिकारी यांचे मार्गदर्शनाखाली काम करणे कंपनीस बंधनकारक राहिल.
२२. सदर केबल प्रकरणीचे प्रस्तावांतर्गत संबंधितांनी पुरविलेले कागदपत्रे खोटे अगर दिशाभूल करणारी आढळून आल्यास देण्यात येणारी परवानगी तात्काळ रद्द करण्यात येईल.
२३. सा. बां. विभागाचे क्षेत्रीय अधिका-यांचे देखरेखीखाली ऑप्टिकल फायबर केबल टाकणेसाठी रस्ता खोदाईचे काम हाती घ्यावे. परस्पर रस्ता खोदाई कंपनीस करता येणार नाही.
२४. जि.प.चे अधिपत्याखाली इतर जिल्हा मार्ग व ग्रामीण मार्ग बाबत केबलचे खोदाईसाठी त्यांचेकडून परवानगी घ्यावी.
