#### Order:-

#### 2. This 'in-principle' approval is issued subject to the following conditions-

- 1) The legal status of the land shall remain unchanged.
- 2) Cost of plantation (including ten years maintenance) of 300 trees shall be levied from the User Agency towards Compensatory Afforestation. As far as possible, a mixture of local indigenous species along with 10% RET species of Sangli District shall be planted and monoculture of any species may be avoided. Afforestation will be carried on degraded forest land, details such as kml, latitude-longitude, record of rights, plan for afforestation of the proposed degraded forest land should be submitted to the State Government along with Stage-I compliance report.


