Dear Sir,

As you are aware Gujarat Gas Limited, a company promoted by Government of Gujarat is in process to devlop City Gas Distribution Network in Thane GA.

The above said proposal has been uploaded online having proposal no. FP/MH/Others/23102/2016, dated 17.12.2016 & subsequently submitted hard copy on dtd. 03.01.2017 for Permission of laying natural gas pipeline passing through various Forest area.

Further, we have received a letter from your good office vide letter ref. (3) regarding the submission of compliance as per the letters given by the State Government, Maharashtra. In this regard, we would like to inform you that all necessary requirements as and when asked by Forest Department has been submitted time to time and all compliance against observation raised by forest department also submitted by the GGL.

Further stating that the survey numbers which are not included in the FRA, the FRA of the survey number has also been requested by forest department. For which Division office were given a copy of the notification of the survey numbers which are not included in the FRA but have been notified in the forest. We also submitted a copy of that notification to the collector and demanded to issue FRA for the remaining survey numbers. But the collector did not agree and said that we cannot issue FRA unless Forest is mentioned in the revenue record. This issue was also raised when the FRA was issued by the Collector, for that meeting held with Collector, CCF and Nodal Officer in the presence of the ACS to CM in the CM's office on 12.04.2018. (MOM of the meeting is attached herewith)
