

३८. सदर गॅस पाईपलाईन प्रकरणीचे प्रस्तावांतर्गत संबंधितांनी पुरविलेले कागदपत्रे खोटे अगर दिशाभूल करणारी आढळून आल्यास देण्यात येणारी परवानगी तात्काळ रद्द करण्यात येईल. तसेच प्रस्ताव धारक कार्यवाहीस पात्र राहील.
३९. सा. बां. विभागाचे क्षेत्रिय अधिका-यांचे देखरेखीखाली गॅस पाईपलाईन टाकणेसाठी रस्ता खोदाईचे काम हाती घ्यावे. परस्पर रस्ता खोदाई कंपनीस करता येणार नाही.
४०. वन जमिनीतून रस्ता जात असल्यास गॅस पाईपलाईन खोदाईसाठी वन विभागाची परवानगी घेतल्याशिवाय कार्यवाही करू नये.
४१. जि.प.चे अधिपत्याखाली इतर जिल्हा मार्ग व ग्रामीण मार्ग बाबत गॅस पाईपलाईन खोदाईसाठी त्यांचेकडून परवानगी घ्यावी.
