No.176 which is required to be acquired is with the forest department and for same permission from forest department is required, followed by, Range Forest Officer, Khandala wrote to Chief Engineer of railway on 03/04/2020 clearly mentioning that the said land is reserved forest land and any Non-forestry work done on forest land will lead to violation. (Both letters as SDO Wai & RFO Khandala attached hereby) This shows that railway authorities are well aware in advance about the status of land.

The Proposal is recommended for acceptance as the project belongs to Central Government Agency and is in the national interest. However, the violation under report may be dealt as per guidelines issued by the MoEF & CC, New Delhi under Para 1.21 (ii) (a) of Handbook of FCA, 1980 & FCR, 2003 (guidelines & Clarification), 2019.
