With reference to above reference letter, observations made by DFO, Beed are clarified as below;

	Compensatory Afforestation shall be taken up by the Forest Department over the area 0.40 ha, Degraded Forest Land in Compartment No. 489A, Gut NO. 447 at Village- Bhawanwadi, Taluka- Beed, District- Beed at the cost of the User Agency. As far as possible, a mixture of local indigenous species along with 10% RET species of Beed District shall be planted and monoculture of any species may be avoided. At least one water body shall be constructed in the form of tank/ stop dams etc if the same are not available in the area or in nearby vicinity. Further, if existing tank/ stop dams are available and needs desilting/ repair, same shall be carried out to meet the water requirement of wild animals throughout the year. Further, KML file Of area identified for raising CA shall be uploaded on <b>PARIVESH</b> portal and intimated to this office along with Stage-I approval.	Compensatory afforestation 0.40 ha Degraded Forest Land in Compartment No. 489A, Gut NO. 447 at Village- Bhawanwadi, Taluka- Beed, District- Beed.
