The discussion has been held at site regarding the Wild life conservation plan. Accordingly DCF (Wild life) Thane vide his letter no. जमीन/1484/2021-22 dated. 14.03.2022. The details are as under,</p> <p><i>"The forest land were the physical work is proposed is adjacent to the Human Habitation and agriculture land and presence of Wild animal is not there, also incidences of Human Wild life conflict are also nil. It was revealed in the joint inspection that mitigation major is not feasible as proposed diversion of forest area for diversion is scattered and in many patches and absent of Wild life. Considering the facts in the proposal, discussions held with forest and Railway officials and based on joint site Inspection, it is recommended to erect chain - link fencing of 8m height and 100m length along both sides of the railway line at both the ends of the tunnels (i.e. before starting point and after the end point of the tunnels) with annual maintenance to avoid entry of any wild animal in the tunnel. It is also recommended to install necessary signage/direction boards depicting messages about wildlife conservation and helpline/contact of forest and railway officials to make people aware about wildlife conservation and to tackle situation of human wildlife conflict, if any in the future."</i></p> <p>Accordingly, wildlife conversation plan has been submitted with incorporating of all the suggestions received from DCF (Wild life) Thane and submitted to DCF Alibag vide letter no. MRVC/W/150/Forest Land dated.15.03.2022 for further action. DCF Alibag has forwarded the wild life conservation plan to APCF (Wild life) Mumbai with his acceptance for the plan. Remarks of MRVC :- *As the wildlife conservation plan prepared based on joint site inspection with DCF Alibag, DCF (Wildlife) Thane. The recommendations and suggestions received from various authorities already been incorporated in the plan. Hence the preparation of site specific 10 years wildlife management plan is not requires. As the new proposed line already been passes through tunnel in the mostly reserve forest area and there is not any disturbance to the forest land and there is sufficient space is available for the free movement of wildlife if any. If any further suggestions received from forest authorities will be followed as per the requirement at forest area other than wildlife conservation plan.*
