

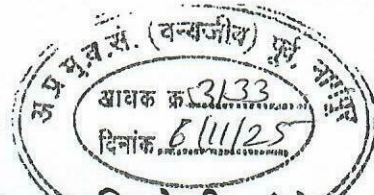

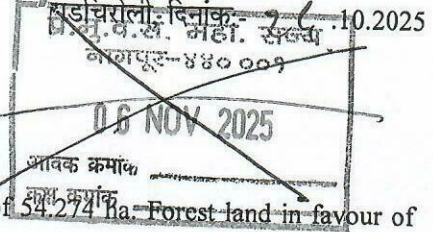

Respected Sir,

The Ministry of Environment, Forest and Climate Change (MoEF&CC) Vide reference letter No.1 has sought clarification on the proposal. The following point are mentioned in the above letter.

*"The State Government is therefore requested to provide a detailed justification for the proposed amendment/exemption sought by the User Agency, along with specific comments of the Chief Wildlife Warden (CWLW), to enable this office to place the matter before the REC for appropriate consideration-----
The specific recommendation of the CWLW regarding the applicability of the Wild Life (Protection) Act, 1972 to the EVL area, and the requirement of prior approval of the SC-NBWL for activities in the said area, may also, be submitted for placing the same before REC"*

In response to reference letter No.2 and 6, the following information and opinion of this undersigned office is submitted for further comments of the CWLW office.

The Maharashtra State Board of Wildlife in its 24th meeting dated 17th April 2025 discussed this subject and its decision is mentioned as follows in its minutes of meeting " The State Board for wildlife decided to accept only tiger corridors as delineated in NTCA's report "Connecting tiger populations for long-term conservation" in 2014-15 and as per the GIS data pertaining to Tiger Reserves, Protected Areas and corridors available under Decision Support System (DSS) on the website of NTCA."

Further, the National Tiger Conservation Authority (NTCA) issued clarification on the subject to all Chief Wildlife Warden of states vide its letter dated 20.8.2025. The following clarification is mentioned in the letter as

"Reference is invited to the subject cited above and the directions given as per 84th Standing committee of National Board for Wildlife. In this context, I am to place on record, the following provisions of law:

20
i. Section 38 O (1) (g) "Ensure that the tiger reserves and areas linking one protected area or tiger reserve with another protected area or tiger reserve are not diverted for ecologically unsustainable uses, except in public interest and with the approval of the National Board for Wildlife and on the advice of the Tiger Conservation Authority;"


ii. Section 38V(3)(b) "Ecologically compatible land uses in the tiger reserves and areas linking one protected area or tiger reserve with another for addressing the livelihood concerns of local people, so as to provide dispersal habitats and corridor for spill over population of wild animals from the designated core areas of tiger reserves or from tiger breeding habitats within other protected areas;"

2. In letter and spirit of the above provisions of law, this Authority has published 32 tiger corridors in its document titled "Connecting tigers for long term conservation". Further, the Tiger Conservation Plan mandated for each tiger reserve under section 38 (V) of the Wildlife (Protection) Act, 1972 and approved by this Authority under section 38 O (1) (a) of the said Act identifies tiger corridors in letter and spirit of section cited at S. No. ii above. There are, thus, two statutory sources which generally apply for the purpose of identifying the Tiger Corridors.

5. Further, the aforesaid matter has been discussed in the 84th meeting of Standing Committee of NBWL and it is hereby clarified that for the purpose of tiger corridors, the States should preferably adhere to those corridors, which have been identified from the aforementioned two sources under the aforesaid provisions of the Wildlife (Protection) Act, 1972."

In this background, the Eastern Vidarbha Landscape (EVL) area (as per WII study 2016) of the present proposal doesn't come under the Tiger corridors as delineated under NTCA report 2014. So, the prior approval of NBWL as per the wildlife protection Act 1972 for activities in said area is not required.

Therefore, we request that you kindly forward the above information for necessary action.

With reference to the subject, it is informed that the Regional Office, Nagpur, vide letter dated 21.11-2023, conveyed in-principle approval for the subject proposal. However, the Nodal Officer, Maharashtra State Forest Department, vide reference cited above, informed this office that the User Agency has now sought exemption from constructing of cross passages as per the condition No .x of the Stage I approval order

In view of the above, it is clarified that any amendment to the approved conditions must be placed before the REC for consideration. Hence, exemption now proposed requires cogent justification. The State Government is therefore requested to provide a detailed justification for the proposed amendment/exemption sought by the User Agency, along with specific comments of the Chief Wildlife Warden (CWLW), to enable this office to place the matter before the REC for appropriate consideration.

Further, the Nodal Officer (FCA), Maharashtra State Forest Department, has informed that, as per the minutes of the 24th State Board for Wildlife (SBWL)

meeting held on 17-04-2025. approval of the National Board for Wildlife (NBWL) is not required for activities within the EVL area of 54.274 ha. as stated in Condition No. xii of the Stage-I approval. However, as per the prevailing rules, any activity proposed within a tiger corridor requires prior approval of both the SBWL and the Standing Committee of the NBWL (SC-NBWL). Therefore, the State Government is requested to clarify whether the User Agency has obtained the prior approval of the SBWL and SC- NBWL. The specific recommendation of the CWLW regarding the applicability of the Wild Life (Protection) Act, 1972 to the EVL area, and the requirement of prior approval of the SC-NBWL for activities in the said area, may also be submitted for placing the same before REC.

This issues with the approval of the Competent Authority, Regional Office, MoEF&CC, Nagpur.

The undersigned is directed to refer to State Government of Maharashtra letter no. FLD-36A22/CR-205/F-10 dated 23.12.2022 and APCCF & Nodal Officer (FCA), Maharashtra Letter No. Desk-17/Nodal/Gadchiroli/ID-12987/1415/2022-23 dated 06.09.2022 on the above subject seeking prior approval of the Central Government under Section- 2 of the Forest (Conservation) Act, 1980 and State Government of Maharashtra letter no. FLD-36A22/CR-205/F-10 dated 16.05.2023 and The Addl. PCCF and Nodal Officer (FCA), Government of Maharashtra, vide his letter no. Desk-17/Nodal/Gadchiroli/ID-12987/417/2023-24 dated 11.05.2023 and The Government of Maharashtra's letter no. FLD-36A22/CR-205/F-10 dated 18.08.2023 and The Addl. PCCF and Nodal Officer (FCA), Government of Maharashtra, vide his letter no. Desk-17/FCA-S1/PID-119248/Gadchiroli/1504 dated 17.08.2023, The Addl. PCCF and Nodal Officer (FCA), Government of Maharashtra, vide his letter no. Desk-17/Nodal/S2/PID-45600/Gadchiroli/2302/2023-24 dated 02.11.2023 forwarding reply to queries raised vide this office letter of even number dated 30.01.2023, 30.06.2023, 20.10.2023 and to say that the said proposal has been examined in the Regional Office in light of the relevant provisions of the Forest (Conservation) Act, 1980 and Guidelines issued thereunder and approved by the Regional Empowered Committee constituted under Section- 4 of the Forest (Conservation) Act, 1980 in its 109th meeting dated 16.11.2023.

After careful examination of the proposal of the State Government and on the basis of the approval of the proposal by the Regional Empowered Committee, the Central Government hereby accords 'in-principle' under Section- 2 of the Forest (Conservation) Act, 1980 for Diversion of 54.274 ha of forest land in favour of Ministry of Road Transport and Highway, Gadchiroli for Up-gradation to 2/4 lane with paved shoulder configuration of Gadchiroli- Allapalli- Sironcha of NH- 353 C from Gitalli- Mosam- Zamela Nalla in Gadchiroli District in the State of Maharashtra subject to the fulfilment of the following conditions:-

- Legal status of the forest land shall remain unchanged;
- Forest land will be handed over only after required non-forest land for raising CA is handed over by the User Agency;

iii. Compensatory afforestation

- a. Compensatory Afforestation will be carried over 110.00 ha. Degraded forest land twice in extent of the area proposed for diversion at the cost of User Agency. Details of 80.00 ha. In the jurisdiction of Allapalli Forest Division are as under:

As far as possible, a mixture of local indigenous species along with 10% RET species of Gadchiroli Districts shall be planted and monoculture of any species may be avoided.;

- b. The non-forest land proposed for CA shall be transferred and mutated in the name of Forest Department and notified as RF/PF prior to Stage-II approval. A copy of the original notification declaring the non-forest land under Section 4 or Section 29 of the Indian Forest Act, 1927, or under the relevant section of the State Forest Act as the case may be, will be submitted by the State Government prior to Stage-II approval;
- iv. The cost of compensatory afforestation at the prevailing wage rates as per compensatory afforestation scheme and the cost of survey, demarcation and erection of permanent pillars if required on the CA land shall be deposited in advance with the Forest Department by the project authority. The CA will be maintained for 10 years. The scheme may include appropriate provision for anticipated cost increase for works scheduled for subsequent years;
- v. NPV:
- a. The State Government shall charge the Net Present Value (NPV) for the 12.2607 ha forest area to be diverted under this proposal from the User Agency as per the orders of the Hon'ble Supreme Court of India dated 30/10/2002, 01/08/2003, 28/03/2008, 24/04/2008 and 09/05/2008 in IA No. 566 in WP (C) No. 202/1995 and as per the guidelines issued by the Ministry vide letters No. 5-1/1998-FC (Pl.II) dated 18/09/2003, letter No. 5-2/2006-FC dated 03/10/2006, letter No. 5-3/2007-FC dated 05/02/2009, letter No. 5-3/2011-FC(Vol-I) dated 06.01.2022 and letter No. 5-3/2011-FC(Vol-I) dated 22.03.2022 in this regard;


- b. Additional amount of the NPV of the diverted forest land, if any, becoming due after finalization of the same by the Hon'ble Supreme Court of India on receipt of the report from the Expert Committee, shall be charged by the State Government from the User Agency. The User Agency shall furnish an undertaking to this effect.
- vi. User agency shall restrict the felling of trees to minimum number in the diverted forest land and the trees shall be felled at the cost of User Agency under the strict supervision of the State Forest Department;
 - vii. All the funds received from the User Agency under the project shall be transferred/ deposited to CAMPA fund only through e-portal (<https://parivesh.nic.in/>);
 - viii. State Government, Maharashtra/ Nodal Officer (FCA), Maharashtra shall ensure settlement of rights under the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 (No. 2 of 2007) before issuing an order for handing over of forest land to the User Agency;
 - ix. The trees having bird nests shall not be felled without written permission from the DCF concerned both in forest as well as non-forest land;
 - x. In conformity with Wildlife Protection Act, 1972 and The Prevention of Cruelty to Animals Act, 1960, the User Agency in consultation with concerned DCF, may provide suitable guided cross passage structures as per need and along possible traditional routes of Wildlife for their smooth movement;
 - xi. Speed regulating signage will be erected along the road at regular intervals in the Protected Areas/ Forest Areas;
 - xii. As per the guideline dated 17.05.2022 issued by the MoEFCC and para 12.3 of the Handbook of Guidelines for Forest (Conservation) Act, 1980, any activity falling in tiger corridors identified by the CWLW shall be carried out only after obtaining the approval from the Standing Committee of NBWL. This approval will not confer any right upon the User Agency for approval from the Standing Committee of NBWL and complete clearance will be viewed to be obtained only when all requisite clearances have been obtained by the User Agency;
 - xiii. User Agency shall obtain Environmental Clearance as per the provisions of the Environmental (Protection) Act, 1986, if applicable;
 - xiv. The layout plan of the proposal shall not be changed without prior approval of Central Government;
 - xv. No labour camp shall be established on the forest land;
 - xvi. Sufficient firewood, preferably the alternate fuel, shall be provided by the User Agency to the labourer after purchasing the same from the State Forest Department or the Forest Development Corporation or any other legal source of alternate fuel;
 - xvii. The boundary of the diverted forest land shall be suitably demarcated on ground at the project cost, as per the directions of the concerned Divisional Forest Officer;
 - xviii. No additional or new path will be constructed inside the forest area for transportation of construction materials for execution of the project work;
 - xix. The period of diversion under this approval shall be co-terminus with the period of lease to be granted in favour of the user agency or the project life, whichever is less;
 - xx. The forest land shall not be used for any purpose other than that specified in the project proposal;
 - xxi. The forest land proposed to be diverted shall under no circumstances be transferred to any other agencies, department, or person without prior approval of Govt. of India;

- xxii. Violation of any of these conditions will amount to violation of Forest (Conservation) Act, 1980 and action would be taken as per the MoEF&CC Guideline F. No. 11-42/2017-FC dt 29/01/2018;
- xxiii. Any other condition that the Ministry of Environment, Forests & Climate Change may stipulate from time to time in the interest of conservation, protection and development of forests & wildlife;
- xxiv. The compliance report shall be uploaded on e-portal (<https://parivesh.nic.in/>);

After receipt of a report on the compliance of conditions no iii (a) & (b), iv, v (a), vii, and undertakings, duly authenticated by the competent authority in the State Government, in respect of all other conditions, from the State Government, formal approval will be considered in this regard under Section-2 of the Forest (Conservation) Act, 1980.



The Ministry of Environment, Forest and Climate Change (MoEF&CC) Vide reference letter No.1 has sought clarification on the proposal. The following point are mentioned in the above letter.

*"The State Government is therefore requested to provide a detailed justification for the proposed amendment/exemption sought by the User Agency, along with specific comments of the Chief Wildlife Warden (CWLW), to enable this office to place the matter before the REC for appropriate consideration-----
The specific recommendation of the CWLW regarding the applicability of the Wild Life (Protection) Act, 1972 to the EVL area, and the requirement of prior approval of the SC-NBWL for activities in the said area, may also, be submitted for placing the same before REC"*

In response to reference letter No.2 and 6, the following information and opinion of this undersigned office is submitted for further comments of the CWLW office.

The Maharashtra State Board of Wildlife in its 24th meeting dated 17th April 2025 discussed this subject and its decision is mentioned as follows in its minutes of meeting " The State Board for wildlife decided to accept only tiger corridors as delineated in NTCA's report "Connecting tiger populations for long-term conservation" in 2014-15 and as per the GIS data pertaining to Tiger Reserves, Protected Areas and corridors available under Decision Support System (DSS) on the website of NTCA."

Further, the National Tiger Conservation Authority (NTCA) issued clarification on the subject to all Chief Wildlife Warden of states vide its letter dated 20.8.2025. The following clarification is mentioned in the letter as

"Reference is invited to the subject cited above and the directions given as per 84th Standing committee of National Board for Wildlife. In this context, I am to place on record, the following provisions of law:

i. Section 38 O (1) (g) "Ensure that the tiger reserves and areas linking one protected area or tiger reserve with another protected area or tiger reserve are not diverted for ecologically unsustainable uses, except in public interest and with the approval of the National Board for Wildlife and on the advice of the Tiger Conservation Authority;"

ii. Section 38V(3)(b) "Ecologically compatible land uses in the tiger reserves and areas linking one protected area or tiger reserve with another for addressing the livelihood concerns of local people, so as to provide dispersal habitats and corridor for spill over population of wild animals from the designated core areas of tiger reserves or from tiger breeding habitats within other protected areas;"

2. In letter and spirit of the above provisions of law, this Authority has published 32 tiger corridors in its document titled "Connecting tigers for long term conservation". Further, the Tiger Conservation Plan mandated for each tiger reserve under section 38 (V) of the Wildlife (Protection) Act, 1972 and approved by this Authority under section 38 O (1) (a) of the said Act identifies tiger corridors in letter and spirit of section cited at S. No. II above. There are, thus, two statutory sources which generally apply for the purpose of identifying the Tiger Corridors.

5. Further, the aforesaid matter has been discussed in the 84th meeting of Standing Committee of NBWL and it is hereby clarified that for the purpose of tiger corridors, the States should preferably adhere to those corridors, which have been identified from the aforementioned two sources under the aforesaid provisions of the Wildlife (Protection) Act, 1972."

In this background, the Eastern Vidarbha Landscape (EVL) area (as per WII study 2016) of the present proposal doesn't come under the Tiger corridors as delineated under NTCA report 2014. So, the prior approval of NBWL as per the wildlife protection Act 1972 for activities in said area is not required.

Therefore, we request that you kindly forward the above information for necessary action.
