Compensatory afforestation a) Compensatory afforestation shall be taken up by the Forest Department over 13.00 ha. degraded Forest land at Compartment No. 427 in Village- Lakh, Taluka- Pachora, District Jalgaon at the cost of the User Agency. As far as possible, a mixture of local indigenous species along with 10% RET species of Jalgaon District shall be planted and monoculture of any species may be avoided. At least two water bodies shall be constructed in the form of tanks/stop dams etc if the same are not available in the area or in nearby vicinity. Further, if existing tanks/stop dams are available and needs desilting/repair; same shall be carried out to meet the water requirement of wild animals throughout the year;	Compensatory afforestation shall be taken up by the Forest Department over 13.00 ha. degraded Forest land at Compartment No. 427 in Village- Lakh, Taluka- Pachora, District Jalgaon at the cost for compensatory afforestation as per model no. 5 Honorable Principal Chief conservator of Forest (Head of Forest Force) letter no.B/Desk-4/Land/254 /2023-24 dt.03/05/2023 for the year 2023-24 is Rs.9,57,780/- per hectore. NPV: a) The State Government shall charge the Net Present Value (NPV) for the 6.295 ha forest area to be diverted under this proposal from the User Agency as per the orders of the Hon'ble Supreme Court of India dtd. 30/10/2002, 01/08/2003, 28/03/2008, 24/04/2008 & 09/05/2008 in IA No. 566 in WP(C) No. 202/1995 and as per the guidelines issued by the Ministry vide letters No.5-1/1998-FC (Pt. II) dtd. 18/09/2003, letter no. 5-2/2006-FC dtd. 03/10/2006, letter No. 5-3/2007-FC dated 05/02/2009, letter No. 5-3/2011-FC (Vol-I) dtd. 06/01/2022 and letter No. 5-312011-FC (Vol-I) dtd. 22/03/2022 in this regard; b) Additional amount of the NPV of the diverted forest land, if any, becoming due after finalization, of the same by the Hon'ble Supreme Court of India on receipt of the report from the Expert Committee, shall be charged by the State Government from the User Agency. The User Agency shall furnish an undertaking to this effect;	According to Letter No. 5-3 / 2011-FC (Vol-I) from Central Government regarding density - 0.3, eco value class - III, open forest as per the site inspection report dated 11.08.2021 by the Deputy Conservator of Forests, Jalgaon. As shown in 03.05.2023, the amount of Rs. 2,33,95,709/- has been deposited through challan generated from PARIVESH Portal.
V.	User agency shall restrict the felling of trees to minimum number in the diverted forest land and the trees shall be felled under the strict supervision of the State Forest Department and the cost of felling of trees shall be deposited by the User Agency with the State Forest Department. Maximum numbers of trees in outer RoW will be kept intact;	Demand Draft (D.D.) in the name of Deputy Conservator of Forests, Jalgaon Forest Department, Jalgaon will be deposited at his office.

VII.	The State Government, Maharashtra/Nodal Officer (FCA), Maharashtra shall ensure settlement of rights under the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 (No. 2 of 2007) before issuing an order for handing over of forest land to the User Agency as per Rule-9(6)(b)(ii) of Forest (Conservation) Rules, 2002 dated 28/06/2022;	FRA Certificate has been enclosed.
VIII.	To improve the Forest/Tree cover and to reduce pollution in the State, as mandated in National Forest Policy, 1988 and Environmental (Protection) Act, 1986 respectively, the User Agency with involvement of Joint Forest Management Committees (JFMC's) and in consultation with local DCF shall raise at least 10,000 seedlings of forestry species along with bamboo, fruit bearing, medicinal, ornamental and indigenous/local for 10 years. At least 50% of seedlings shall be planted in the vicinity of project area and remaining 50% of seedlings shall be distributed among villagers as per choice of villagers. The concerned JFMC's shall maintain record of plantation/ seedling distribution to villagers;	Undertaking Enclosed.



IX.	The trees having bird nests shall not be felled without written permission from the DCF concern both in forest as well as non-forest land;	Undertaking Enclosed.
X.	The Forest Department shall carryout the avenue plantation by planting 8 feet tall suitable species outside RoW passing through the Forest Areas as well as non-forest areas as per the IRC norms at the cost of User Agency;	Undertaking Enclosed.
XI.	For smooth movement of resident wildlife and cattle all hume pipes in the forest area shall be converted in to the box culverts of at least 2x3 meters size in consultation with the DCF concern. XII.	The existing carriageway in the forest area, in the patches corresponding to re-alignments, shall be dismantled and land shall be handed over back to the State Forest Department. 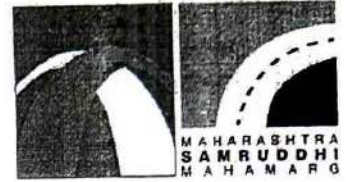

In forest length of 2.300 km (Ch.21/00 to 23/300), as per forest department instructions we are providing 2m x 3m Box culverts at every 500m for safe passage to wildlife and cattle in conformity with the wild life protections Act 1972. In non-forest length, work of PQC with structures is completed. As it will affect the approved plans and profiles of road. So now it is not possible to convert HP drains to Box culvert.

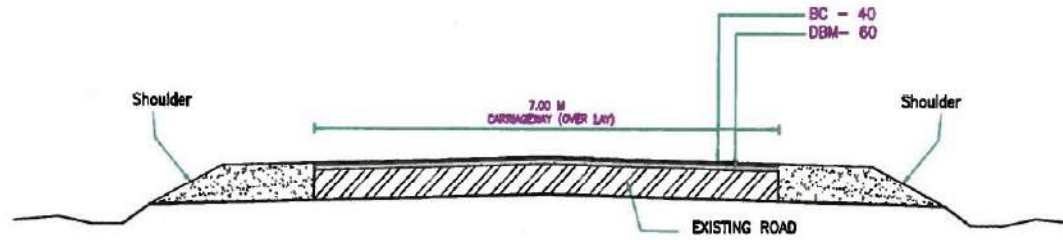


TYPICAL CROSS SECTION : 2.2\_A

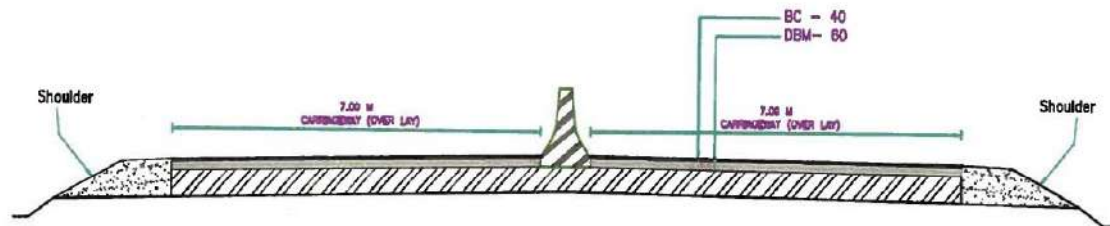




TYPICAL CROSS SECTION - 23\_A

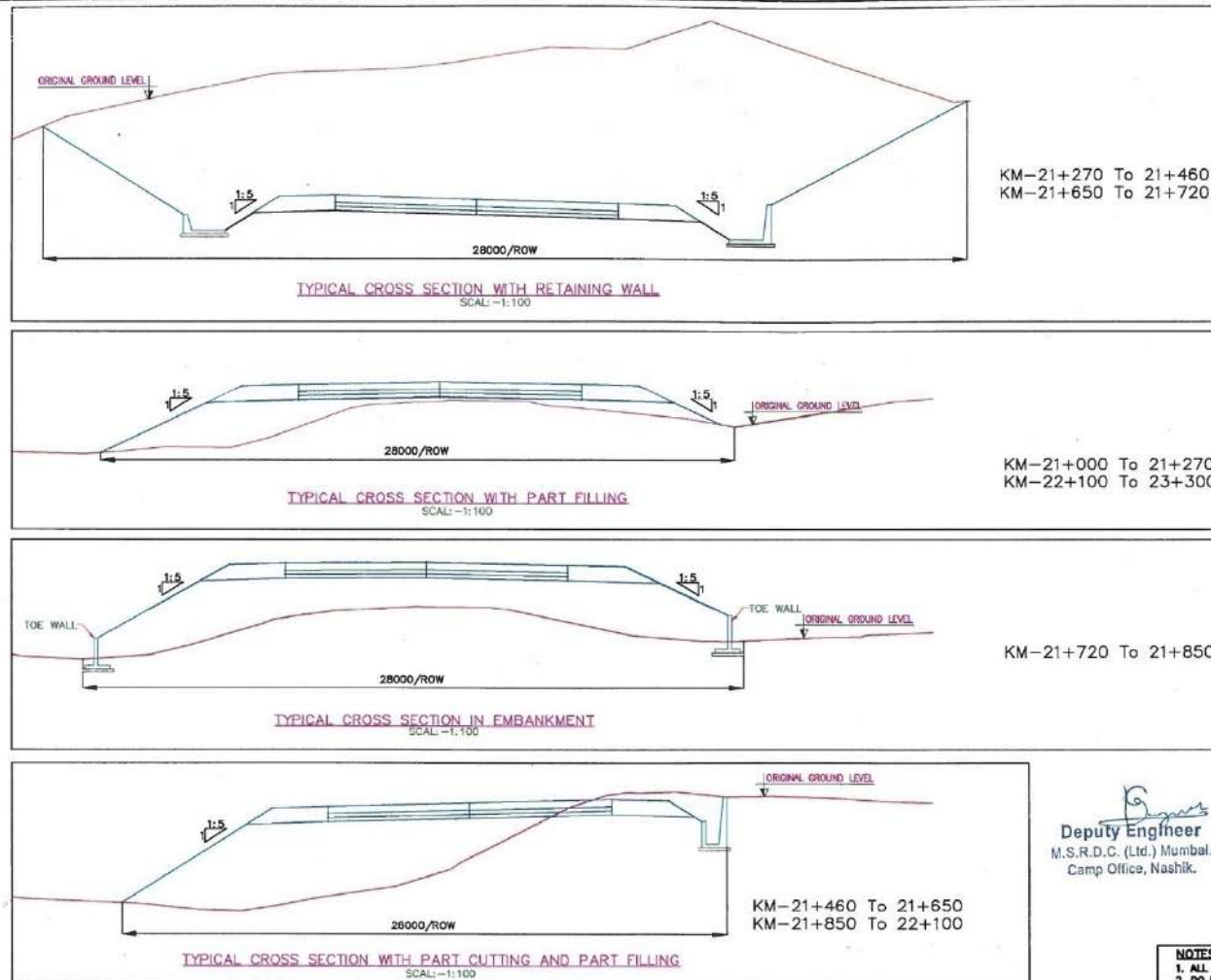

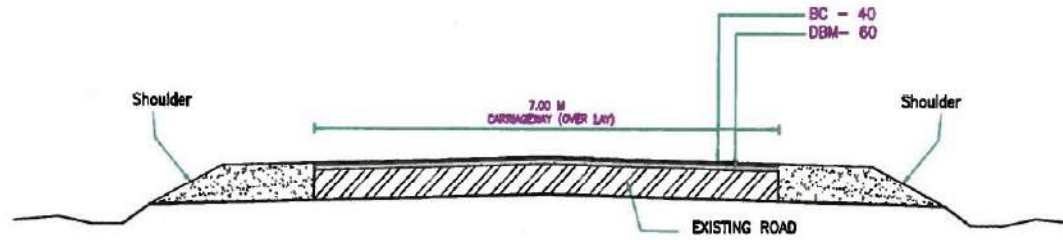


TYPICAL CROSS SECTION : 2.2\_A

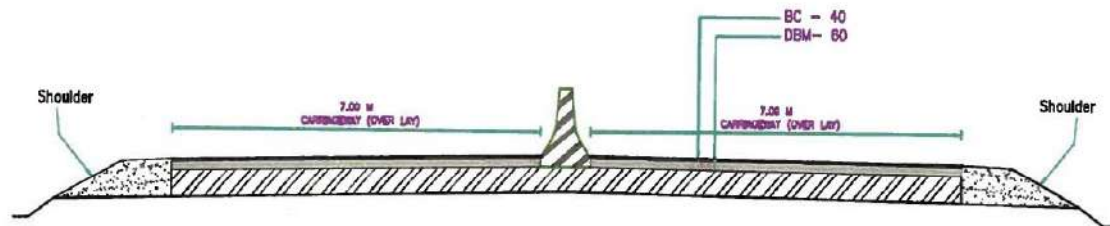




TYPICAL CROSS SECTION - 23\_A

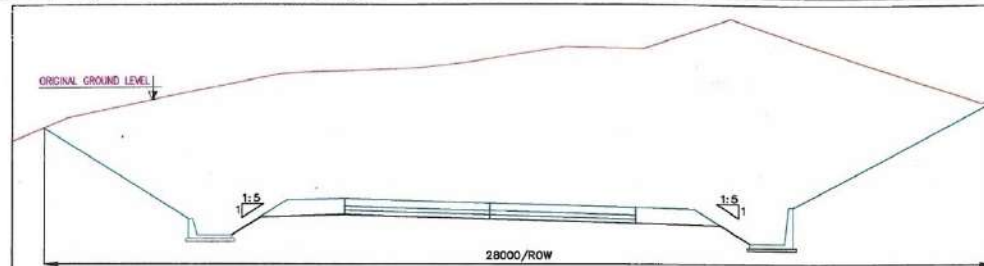

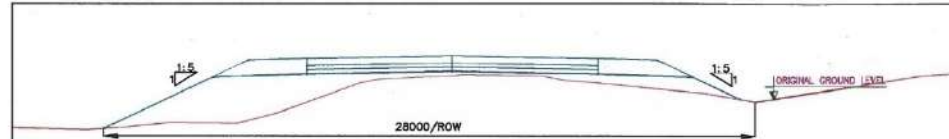


# Proposed typical cross section of road in Forest area



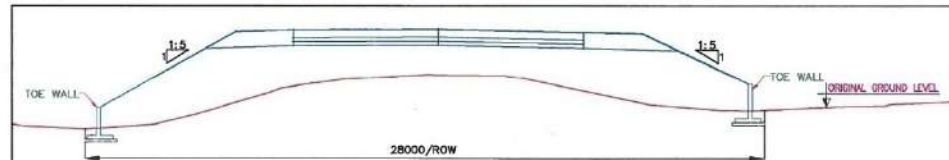

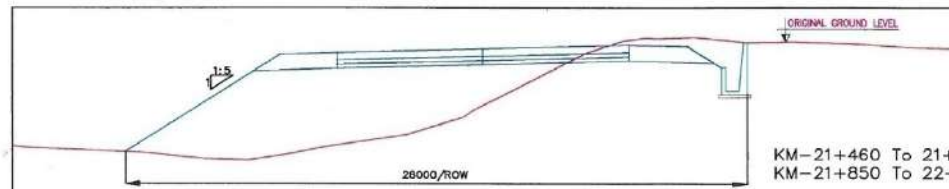

Sub: Diversion of 6.295 ha of Reserved Forest land in favour of MSRDC, Mumbai for Rehabilitation and Up-gradation of Pahur-JamnerBodhwad-Muktainagar-Barhanpur(Km 0+000 to Km 78+145,NH-753 L) to two lane with paved shoulder in Villages- Jamner&Sonari, Taluka- Jamner, District- Jalgaon in the State of Maharashtra-regarding.

Sir,

The undersigned is directed to refer to State Government of Maharashtra letter no. FLD-1922/CR-206/F-10 dated 10.11.2022 and The APCCF & Nodal Officer (FCA), Maharashtra Letter No. Desk-17/Nodal/Dhule/ID-13054/1017/2022-23 dated 22.07.2022 on the above subject seeking prior approval of the Central Government under Section-2 of the Forest (Conservation) Act, 1980 and APCCF & Nodal Officer (FCA), Maharashtra letter no. Desk-17/2/Nodal/ID-13054(31)/2776/2022-23 dated 18.01.2023 and State Government of Maharashtra letter no. FLD-1922/C.R.206/F-10 dated 13.03.2023 forwarding additional information as sought by this Office vide letter of even number dated 27.12.2022 and 17.02.2023 and to say that the said proposal has been examined in the Integrated Regional Office in light of the relevant provisions of the Forest (Conservation) Act, 1980 and Guidelines issued thereunder.

After careful examination of the proposal of the State Government and on the basis of the approval of the proposal by the Regional Empowered Committee, the Central Government hereby accords 'in-principle' approval under Section- 2 of the Forest (Conservation) Act, 1980 for diversion of 6.295 ha of Reserved Forest land in favour of MSRDC, Mumbai for Rehabilitation and Up-gradation of Pahur-JamnerBodhwad-Muktainagar-Barhanpur(Km 0+000 to Km 78+145,NH-753 L) to two lane with paved shoulder in Villages- Jamner&Sonari, Taluka- Jamner, District- Jalgaon in the State of Maharashtra subject to the fulfilment of the following conditions:-

- Legal status of the forest land shall remain unchanged;
- Compensatory afforestation**
  - Compensatory afforestation shall be taken up by the Forest Department over 13.00 ha. degraded Forest land at Compartment No. 427 in Village- Lakh, Taluka- Jamner, District- Jalgaon at the cost of the User Agency. As far as possible, a mixture of local indigenous species along with 10% RET species of Jalgaon District shall be planted and monoculture of any species may be avoided. At least two water bodies shall be constructed in the form of tank/ stop dams etc if the same are not available in the area or in nearby vicinity. Further, if existing tanks/ stop dams are available and needs desilting/ repair; same shall be carried out to meet the water requirement of wild animals throughout the year;
- The cost of compensatory afforestation at the prevailing wage rates as per compensatory afforestation scheme and the cost of survey, demarcation and erection of permanent pillars if



required on the CA land shall be deposited in advance with the Forest Department by the project authority. The CA will be maintained for 10 years. The scheme may include appropriate provision for anticipated cost increase for works scheduled for subsequent years;

iv. **NPV:**

- a) The State Government shall charge the Net Present Value (NPV) for the 6.295 ha forest area to be diverted under this proposal from the User Agency as per the orders of the Hon'ble Supreme Court of India dated 30/10/2002, 01/08/2003, 28/03/2008, 24/04/2008 and 09/05/2008 in IA No. 566 in WP (C) No. 202/1995 and as per the guidelines issued by the Ministry vide letters No. 5-1/1998-FC (Pt.II) dated 18/09/2003, letter No. 5-2/2006-FC dated 03/10/2006, letter No. 5-3/2007-FC dated 05/02/2009, letter No. 5-3/2011-FC (Vol-I) dated 06.01.2022 and letter No. 5-3/2011-FC (Vol-I) dated 22.03.2022 in this regard;
  - b) Additional amount of the NPV of the diverted forest land, if any, becoming due after finalization of the same by the Hon'ble Supreme Court of India on receipt of the report from the Expert Committee, shall be charged by the State Government from the User Agency. The User Agency shall furnish an undertaking to this effect;
- v. User agency shall restrict the felling of trees to minimum number in the diverted forest land and the trees shall be felled under the strict supervision of the State Forest Department and the cost of felling of trees shall be deposited by the User Agency with the State Forest Department. Maximum numbers of trees in outer RoW will be kept intact;
  - vi. All the funds received from the User Agency under the project shall be transferred/ deposited to CAMPA fund only through **e-portal** (<https://parivesh.nic.in/>);
  - vii. The State Government, Maharashtra/ Nodal Officer (FCA), Maharashtra shall ensure settlement of rights under the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 (No. 2 of 2007) before issuing an order for handing over of forest land to the User Agency as per Rule- 9 (6) (b) (ii) of Forest (Conservation) Rules, 2022 dated 28.06.2022;
  - viii. To improve the Forest/ Tree cover and to reduce pollution in the State, as mandated in National Forest Policy, 1988 and Environmental (Protection) Act, 1986 respectively, the User Agency with involvement of Joint Forest Management Committees (JFMC's) and in consultation with local DCF shall raise at least 10,000 seedlings of forestry species along with bamboo, fruit bearing, medicinal, ornamental and indigenous/local for 10 years. At least 50% of seedlings shall be planted in the vicinity of project area and remaining 50% of seedlings shall be distributed among villagers as per choice of villagers. The concerned JFMC's shall maintain record of plantation/ seedling distribution to villagers;
  - ix. The trees having bird nests shall not be felled without written permission from the DCF concern both in forest as well as non-forest land;
  - x. The Forest Department shall carryout the avenue plantation by planting 8 feet tall suitable species outside RoW passing through the Forest Areas as well as non-forest areas as per the IRC norms at the cost of User Agency;
  - xi. For smooth movement of resident wildlife and cattle all hume pipes in the forest area shall be converted in to the box culverts of at least 2x3 meters size in consultation with the DCF concern. A report in this regard shall be submitted along with the Stage-I compliance report;
  - xii. The existing carriageway in the forest area, in the patches corresponding to re-alignments, shall be dismantled and land shall be handed over back to the State Forest Department. A reclamation plan by planting suitable species of trees need to be prepared in consultation with the Forest Department and the amount so required will be deposited with the forest department by the User Agency for taking up reclamation of the area. A copy of plan so prepared shall be submitted to Regional Office, Nagpur along with the Stage-I compliance;




- xiii. Speed regulating signage will be erected along the road at regular intervals in the Protected Areas/ Forest Areas;
- xiv. User Agency shall obtain Environmental Clearance as per the provisions of the Environmental (Protection) Act, 1986, if applicable;
- xv. The layout plan of the proposal shall not be changed without prior approval of Central Government;
- xvi. No labour camp shall be established on the forest land;
- xvii. Sufficient firewood, preferably the alternate fuel, shall be provided by the User Agency to the labourer after purchasing the same from the State Forest Department or the Forest Development Corporation or any other legal source of alternate fuel;
- xviii. The boundary of the diverted forest land shall be suitably demarcated on ground at the project cost, as per the directions of the concerned Divisional Forest Officer;
- xix. No additional or new path will be constructed inside the forest area for transportation of construction materials for execution of the project work;
- xx. The period of diversion under this approval shall be co-terminus with the period of lease to be granted in favour of the user agency or the project life, whichever is less;
- xxi. The forest land shall not be used for any purpose other than that specified in the project proposal;
- xxii. The forest land proposed to be diverted shall under no circumstances be transferred to any other agencies, department or person without prior approval of Govt. of India;
- xxiii. Violation of any of these conditions will amount to violation of Forest (Conservation) Act, 1980 and action would be taken as per the MoEF&CC Guideline F. No. 11-42/2017-FC dt 29/01/2018;
- xxiv. Any other condition that the Ministry of Environment, Forests & Climate Change may stipulate from time to time in the interest of conservation, protection and development of forests & wildlife;
- xxv. The compliance report shall be uploaded on e-portal (<https://parivesh.nic.in/>);

After receipt of a report on the compliance of conditions no iii, iv (a), v, vi, xi, xii and undertakings, duly authenticated by the competent authority in the State Government, in respect of all other conditions, from the State Government, formal approval will be considered in this regard under Section-2 of the Forest (Conservation) Act, 1980.
