The work of four laning from Aurangabad (Km. 290+200) to Karodi (Km. 320+640) Package 1A project section of NH-52 (Old NH-211) has been completed and Completion Certificate issued on dt. 01.02.2022 to EPC Contractor. 1<sup>st</sup> Stage forest clearance for 11.78 Ha. of forest land has been received by MoEF vide letter dt. 15.02.2019 & subsequently working permission has been received and four laning work is completed.

2. In compliance to observation received by the Assistant Inspector General of Forest (Central) IRO, MoEF& CC, Nagpur vide letter dt. 18.10.2022.
