



FLD-2018/CR-324/F-10 dated 14.12.2018 and APCCF & Nodal Officer (FCA), Maharashtra letter No. Desk-17/NC/I/I.D-/1697/17-18 dated 01.12.2018 on the above subject seeking prior approval of the Central Government under Section-2 of the Forest (Conservation) Act, 1980 and Nodal Officer (FCA). Maharashtra letter no. Desk-17/NC/RS-I/ID- 12677/1989/18-19 dated 24.01.2019 and letter No. Desk-17/NC/RS-I/ID-12677/2151/18-19 dated 12.02.2019 forwarding additional information as sought by this Office vide letter of even number dated 07.01.2019 and 01.02.2019 and to say that the said proposal has been examined and approved by the Regional Empowered Committee constituted under Section - 4 of the Forest (Conservation) Act, 1980.

After careful examination of the proposal of the State Government and on the basis of the approval of the proposal by the Regional Empowered Committee, the Central Government hereby accords 'in-principle' under Section - 2 of the Forest (Conservation) Act, 1980 for diversion of 11.78 ha Reserved Forest Land in favour of National Highway Authority of India (NHAI), PIU- Aurangabad for Rehabilitation and Up-gradation of existing two lane to four lane of Aurangabad- Koradi section of NH-211, to 4 lane from km 290.200 to Km 376.000 and Km 390.000 to Km 452.800 (Design Chainage 290.200 Km in Aurangabad to Koradi 320.640 Km) with partial green field alignment as bypass to Aurangabad city in Aurangabad District in the State of Maharashtra subject to the fulfilment of the following conditions:

- Legal status of the diverted forest land shall remain unchanged;
- ii. Compensatory afforestation, over non-forest land, equal in extent to the area proposed for diversion, shall be raised and maintained by the State Forest Department at the cost of the User Agency;
- iii. The non-forest land identified for raising compensatory afforestation shall be transferred and mutated in favour of the State Forest Department before issue of the Stage-II clearance;

- iv. The scheme may include appropriate provision for anticipated cost increase for works scheduled for subsequent years;
- vi. The State Government shall charge the Net Present Value (NPV) of the forest land being diverted under this proposal from the User Agency as per the orders of the Hon'ble Supreme Court of India dated 28.03,2008, 24.04,2008 and 09.05,2008 in Writ Petition (Civil) No. 202/1995 and the guidelines issued by this Ministry vide its letter No. 5-3/2007-FC dated 05.02,2009 in this regard;
- vii. At the time of payment of the Net Present Value (NPV) at the then prevailing rate, the User Agency shall furnish an undertaking to pay the additional amount of NPV, if so determined, as per the final decision of the Hon'ble Supreme Court of India;
- viii. All the funds received from the user agency under the project, except the funds realized for regeneration/ demarcation of safety zone, shall be transferred to CAMPA through e-challan in the Savings Bank Account pertaining to the State concerned;
- The User Agency shall obtain the Environment Clearance as per the provisions of the Environmental (Protection) Act, 1986, if required;
- x. The boundary of the diverted forest land, shall be demarcated on ground at the project cost, by erecting four feet high reinforced cement concrete pillars, each inscribed with its serial number, forward and back bearing and distance from pillar to pillar;
- xi. The User Agency shall arrange to raise strip plantation on either side of the road and central verge at project cost, as per IRC specification, with maintenance of 7-10 years. xxvi. Alignment of road passing through the forest patch should be provided with appropriate underpasses points to ensure safe movement of wildlife across the expressway. Provision of guided fencing may be provided at the crossing points to guide the wildlife to cross the expressway through the underpasses points. Location of underpasses shall be fixed in consultation with the PCCF (Wildlife). Maharashtra. Detail of the same shall be submitted along with Stage-I compliance report:

xxvii. Any tree felling shall be done only when it is unavoidable and that too under strict supervision of the State Forest Department;

xxviii. Maximum number of trees up to 60 Cm girth proposed to be felled may be translocated by the State Government at the cost of the User Agency;


