उपरोक्त विषयान्तर्गत लेख है कि वनमंडल दक्षिण पन्ना अंतर्गत 21 हेक्टेयर संरक्षित वनभूमि 33 केव्ही सलेहा से कल्दा विद्युत लाईन निर्माण हेतु संदर्भित पत्र क्रमांक 01 के माध्यम से निर्धारित शर्तों के अधीन प्रथम चरण की स्वीकृति प्रदान की गई है।

प्रदान की गई स्वीकृति में दी गई समस्त शर्तों का पालन करने हेतु अनुबंधानुसार आवेदक संस्था म०प्र०पू०क्षे०वि०वि०क०लि० पन्ना वचनबद्ध है। पत्र में दी गई शर्तों का निम्नानुसार पालन किया जावेगा :-

1	Cost of compensatory afforestation on the CA land (42.00 ha DFL) at the prevailing wage rates as per compensatory afforestation scheme (including cost of survey, demarcation and erection of permanent pillars etc. as required for securing the land against encroachment) shall be deposited in advance with the State Forest Department by the project authority. 
