With reference to the subject and letter no cited above, I am submitting herewith compliance report of IPA as per condition stipulated by Ministry of EF&CC vide letter No 3-MZ B 022/2021-SHI/675-76 Dt. 03.06.2022 as follows:-

**A. Conditions which need to be complied prior to handing over of forest land by the State Forest Department**

The user agency shall transfer, the Net Present Value (NPV) of the forest land being diverted under this proposal, as per the Ministry's guideline No 5-3/2011-FC Vol - I) dated 06.01.2022 and even No Dt 19.01.2022. The requisite funds shall be transferred through online portal into CAMPA account of the State concerned. 4.	The compliance of the FRA, 2006 shall be ensured by way of prescribed certificate from the District Collector.	Not Applicable

The KML file of the area to be diverted, the CA area shall be uploaded on the e-green watch portal with all requisite details before issuing working permission towards linear projects or submitting compliance report for seeking Stage II approval as the case may be;	To be complied by State Forest Department.
6.	The boundary of the diverted forest land shall be suitably demarcated on ground at the project cost, as per the direction of the concerned Divisional Forest Officer and amount to be deposited with State Forest Department;	Fund will be deposited after receiving demand note from State Forest Department.
7.	The cost of felling of trees shall be deposited by User Agency with the State Forest Department	There is no trees to be felled in the proposed area.
8.	Violation of any of these conditions will amount to violation of Forest (Conservation) Act, 1980 and action would be taken as prescribed in para 1.21 of Chapter 1 of the Handbook of comprehensive guidelines of Forest (Conservation) Act, 1980 as issued by this Ministry's letter No. 5-2/2017-Fc dated 28.03.2019	Noted.



1.	Legal status of the diverted forest land shall remain unchanged	Noted

The Compensatory Afforestation shall be taken up by way of planting 141 trees as per the scheme and fund deposited by user agency; the tree planting to be taken at a close spacing of 1.0 to 1.5 meters keeping an offset of 1.5 meters from the boundary, with light crown trees for the greenery	To be complied by the State Forest Department.
3.	The forest land proposed to be diverted shall under no circumstances be transferred to any other agency, department or person without prior approval of the Central Government.	Undertaking certificate enclosed at annexure I
4.	No damage to the flora and fauna of the adjoining area shall be caused;	Undertaking certificate enclosed at annexure II
5.	The layout plan of the proposal shall not be changed without the prior approval of the Central Government;	Undertaking certificate enclosed at annexure III
6.	The concerned Divisional Forest Officer will monitor and take necessary mitigative measures to ensure that there is no adverse impact on the forest in the surrounding	To be complied by State Forest Department.
7.	The user agency shall undertake plantation along the approach road, separator island and other vacant areas in addition to the compensatory afforestation, required to be raised as per the extant rules.	Undertaking certificate enclosed at annexure IV
8.	The user agency shall submit the annual self compliance report in respect of the above stated condition to the State Government, concerned Regional Office and to this Ministry by the end of March every year.	Noted.
9.	The User Agency shall comply all the provisions of the all Acts, Rules, Regulations, Guidelines, Hon'ble Court order (s) and NGT order (s) pertaining to this project, if any for the time being in force, as applicable to the project.	Noted.
10	All other clearance/NOC under different applicable rules/regulations/local laws and under Forest Dwellers (Recognition of Forest Right Act, 2006 as required vide MoEF, New Delhi guideline No. 11-9/1998-FC(Pt) dated 03.08.2009 shall be complied with	Noted.
11	As per Ministry's letter No. 11-30/96-FC (Pt) Dt. 14.09.2001, if the compliance of stipulated conditions is awaited from the State Govt. more than 5 (five) years, the In Principle Approval would be summarily revoked considering that the user agency is no longer interested in the project.	Noted.
