## Dear Sir,

As per the the stage-I/In Principal approval order no. 5-ORB460/2021-BHU dated 04.05.2021 mentioned under reference 1 above, following conditions have been complied required for final/Stage-II approval:

 An amount of Rs. 29,422/- (Rupee Twenty nine thousand four hundred twenty two only) towards the net present value (NPV) of 0.047 ha. of forest land vide challan application no. 7064022074 dated 26.07.2020.(Through NEFT)

2. An amount of Rs. 9,34,932/- (Rupees Nine lakh thirty four thousand nine hundred thirty two only) towards cost of plantation of 100 nos. of trees as per approved scheme vide challan application no. 7064022091 dated 02.08.2021.(Through NEFT)

 FRC/No Objection Certificate under FRA 2006 has been received from District Collector Jharsuguda vide letter No. 295 dated 03.03.2023.

4. The boundary of the proposed forest land for diversion has been demarcated on ground by creating four feet high RCC pillars

5. Compliance in form of undertaking regarding conditions which need to be strictly complied after stage-II clearance has been enclosed herewith.

All the conditions required for stage-II approval has been complied as detailed above and compliance of stage-I approval was uploaded on the e-portal: <a href="https://parivesh.nic.in">https://parivesh.nic.in</a>. But it was rejected on the e-portal citing the reason that "The hard copy of the stage —I compliance has not yet been received by this office. # A: Conditions which need to be complied prior to handing over of forest land by the state Forest department.

i) The user agency shall transfer online, the Net Present Value (NPV) Of forest land being diverted under this proposal, as per the Orders of Hon'ble Supreme Court of India dated 28.03.2008, 24.04.2008 and 09.05.2008 in writ petition (Civil) No. 202/1995 and the guidelines issued by this Ministry vide its Letter No. 5-3/2007-FC dated 05.02.2009. The requisite funds shall be transferred through online portal in CAMPA account of the State concerned.

In compliance to the above condition, an amount of Rs.29,422/- (Rupee Twenty nine thousand four hundred twenty two only) towards the net present value (NPV) of 0.047 ha. of forest land vide challan application no. 7064022074 dated 26.07.2020 (NEFT) was deposited in the CAMPA account through e-payment mode. The copy of the challan is signed and enclosed in Annexure-I.

ii) The user agency shall transfer the cost of plantation of 100 nos. plants (including 10 years maintenance) at the current wage rate in consultation with State Forest Department in the account of CAMPA of the concerned State through online portal. The Plantation Scheme may include appropriate provision for anticipated cost increase for works scheduled for subsequent years.

In compliance to above condition, an amount of Rs. 9,34,932/- (Rupees Nine lakh thirty four thousand nine hundred thirty two only) towards cost of plantation of 100 nos. of trees as per approved scheme vide challan application no. 7064022091 dated 02.08.2021(NEFT) was deposited in the CAMPA account through e-payment mode. The copy of the challan is signed and enclosed in Annexure-II. As the payment for plantation is already disbursed, so plantation scheme is not necessary.

iii) All the funds received from the user agency under the project shall be transferred/deposited in CAMPA account only through e-portal. Amount deposited through other mode will not be accepted as compliance of Stage-I clearance

In compliance to above condition, it is certified that all the funds shall be transferred/deposited in CAMPA account only through e-portal.

vi) The boundary of the proposed forest land for diversion, shall be demarcated on ground at the project cost, by erecting four feet high reinforced cement concrete pillar, each inscribed with its serial number, distance from pillar to pillar and GPS co-ordinates.

In compliance to the above condition, the boundary of the proposed forest land for diversion has been demarcated on ground by creating four feet high RCC pillars along with GPS coordinates. (Enclosed in Annexure-IV).

In compliance to the condition, the legal status of forest land for diversion shall remain unchanged. An undertaking to the effect is enclosed in Annexure-V.

ii) The state Govt. shall carry out plantation of ten times the number of trees likely to be felled from forest areas towards compensatory afforestation within three years from the issue of approval as per approved plan /scheme and maintained thereafter, at the cost of user agency. The State Govt. shall inform the site of the plantation. The trees shall be indigenous to the area and naturally growing species shall be planted using intensive planting technique to ensure survival of the plantation.

iii) At the time of payment of Net Present value (NVP) at the then prevailing rate, the user agency shall furnish an undertaking to pay the additional amount of NPV, if so determined, as per the final decision of the Hon 'ble supreme court of India.

In compliance to the above, an undertaking is furnished to the effect that CMPDIL will pay the additional amount of NPV, if so determined, as per final decision of the Hon'ble supreme court of India. (Annexure-VI)

iv) The user agency shall obtain Environmental Clearance as per the provisions Of Environment (Protection) Act. 1980. If applicable.

In compliance to the above condition, CMPDIL shall obtain Environmental Clearance as per the provisions Of Environment (Protection) Act. 1980. If applicable. (Annexure-VII).

v) No labor camp shall be established on the forest land and the user agency shall provide fuels preferably alternate fuels to the labourers and the staff working at the site so as to avoid any damage and pressure on the nearby forest areas.

In compliance to the above condition, an undertaking is furnished for non-establishment of labour camp on the forest land and CMPDIL shall provide

vi) No additional or new path will be constructed inside the forest for any activity related to the project work.

In compliance to the above condition, an undertaking is furnished that no additional or new path will be constructed inside the forest area for any activity related to the project work. (Annexure-IX).

vii) The user agency while executing works, shall not fell any tree or damage forest growth in the surrounding forest area in any manner.

Further, undertaking in this regard is enclosed at Annexure-X.

viii) The layout plan of the proposal forest land shall not be changed without the prior approval of Ministry of Environment, Forest Climate Change.

In compliance to the above condition, an undertaking is furnished that the layout plan of the proposed forest land shall not be changed without the prior approval of Ministry of Environment, Forest & Climate Change. (Annexure-XI).

ix) The forest land shall not be used for any purpose other than that specified in the proposal.

In compliance to the above condition, an undertaking is furnished that the forest land shall not be used for any purpose other than which is enclosed at (Annexure-XII).

x) The forest land proposed to be diverted shall under no circumstances be transferred to any other user agency, department or person without the prior approval of ministry of Environment, Forest & Climate Change.

In compliance to the above condition, an undertaking is furnished that no forest land proposed shall be transferred to any other user agency, department or person without the prior approval of Ministry of Environment, forest & climate change, which is enclosed at (Annexure-XIII).
