Sl No.	Observation	Compliance
1	The PF Notification in respect of non-forest land identified for CA has not been furnished by the State Govt.	The PF Notification in respect of Khajurikhaman Protected Forest is enclosed in <b>Annexure-I</b> .
2	As per DSS analysis of KML file, the identified degraded land is Mostly MDF, so there is a need to verify whether the rest seedlings can be planted in this land. If not possible, alternate land should be identified.	As per ground verification report submitted by the Range Officer, Belpahar Range ( <b>copy enclosed in Annexure-II</b> ), 2446 nos of seedlings over 12.23 ha under ANR@200 can be planted.

In obedience to your instruction I personally visited the site of additional CA land as selected in Amkhaman-Sagarpali RF area and found that the area is suitable for plantation of 2446 nos. of saplings under ANR @200. Suitable area for plantation is available in the peripheral area of the proposed Addl CA land although the inner core area is dense. So, the area may be taken up as site for plantation of 2446 nos. of plants over 12.23 ha under ANR @200.


