Sub:- Sanction of Govt. land measuring Hc. 10.785 of Mouza Rakhapalli in favour of the Secretary to Govt. In Forest & Environment Department, Odisha for raising of compensatory afforestation against utilized of forest land for widening of two lane road from 227/700 to 413/700 Km of N.H-326 in Koraput and Malkangiri District.

In pursuance of rule 11 of Schedule II of OGLS Rule 1983 read with Letter No.22958/R&DM dated 04.08.2014, Letter No. 31312/R&DM dated 24.10.2014 and Notification No 42899/R&DM dtd. 07.11.2009 of Govt. in Revenue and Disaster Management Department, Odisha, Bhubaneswar, sanction of following scheduled of Govt. land is hereby accorded in favour of the Secretary to Govt. in Forest & Environment Department, Odisha towards raising of compensatory afforestation at Rakhapalli on payment of premium, ground rent, cess etc., and subject to following terms and conditions.

3. The land shall revert back to Govt. in Revenue & D.M. Deptt. on free from all encumbrances, if it is not utilized for the purpose for which it is alienated.
4. The land shall not be leased out / sub-leased / transferred / mortgaged /disposed/ conveyed / bequeathed without prior consent / permission of Govt. in Revenue & D.M. Deptt. Odisha.
5. The land user shall take all possible steps to keep the land free from all encumbrances.
6. Infringement of all or any part of the conditions of alienated land shall result immediate reversion of land to the R&DM Deptt. on free from all encumbrances and without payment of any compensations for the land structure, if any erected thereon and for any improvement that might have been carry out on the land.

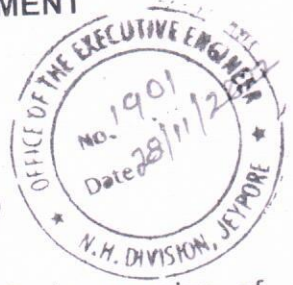

No.FE-DIV-FLD-0089-2022-(10F(Cons)-226/2017)- 20522 /FE&CC, In exercise of the powers conferred under Section 33 of the Odisha Forest Act, 1972 (Odisha Act 14 of 1972), the State Government do hereby declare that the following land situated in Village- **Rekhapalli** under Chitrakonda Tahasil in the District of Malkangiri mutated and transferred in favour of Forest, Environment & Climate Change Department for raising Compensatory Afforestation thereon against proposed diversion of 10.635 ha of forest land for widening to two lane from 327/700 Km to 413/700 Km of NH-326 (erstwhile Km from 16/0 to 102/0 Km of SH-25) under Vijaywada - Ranchi route in Koraput and Malkangiri Districts of Odisha on EPC mode by Executive Engineer, N.H. 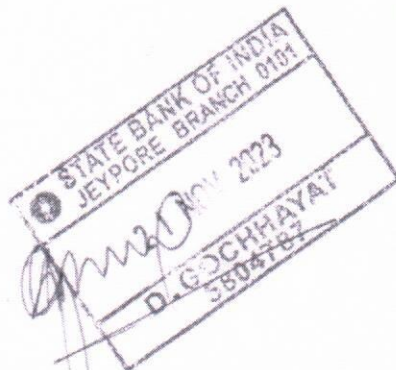
