I am directed to refer to State Govt. letter No.10F(Cons)13/2016-6170/F&E dated 27.03.2017. No.10379/F&F dated 18.05.2017 and No.10525/F&E dated 19.05.2017 on the above mentioned subject seeking prior approval of the Ministry of Environment, Forest & Climate Change under section 2 of Forest(Conservation) Act, 1980.

After due consideration of the proposal of the State Government and on the basis of decision of Regional Empowered Committee meeting held on 03.05.2017, the Ministry of Environment, Forest & Climate Change hereby conveys 'in-principle' approval for diversion of 7.102 ha of Revenue forest land for diverting 220 KV Budhipadar-Basundhara transmission line from Location No.59 to Location No.78 from the premises of STPP, Darlipali, NTPC Ltd. in Sundargarh district, Odisha by M/s Odisha Power Transmission Corporation Ltd., subject to the fulfillment of the following conditions.

- Legal status of forest land proposed for diversion shall remain unchanged.
- The State Govt, shall charge the Net Present Value (NPV) of forest area proposed to be diverted under this proposal from the user agency as per the Orders of Hon'ble Supreme Court of India dated 28.03,2008, 24.04,2008 and 09.05,2008 in Writ Petition (Civil) No.202/1995 and the guidelines issued by this Ministry vide its letter No. 5-3/2007-FC dated 05.02,2009 in this regard. While conveying the compliance of this condition, mention be made of the Eco-class and density of forest for which NPV has been charged.
- At the time of payment of the Net Present Value (NPV) at the present rate, the user agency shall furnish an undertaking to pay the additional amount of NPV, if so determined, as per the final decision of the Hon'ble Supreme Court of India.
- (v) Compensatory afforestation over 7.102 ha of non-forest land identified in Plot No.1264(P) of Khata No.227 (AAA) of Nuadihi village under Lephripara Tahasil of Sundargarh district against the area of forest land proposed to be diverted shall be raised and maintained by the State Forest Department at the cost of the user agency.
- v) The non-forest land identified for raising compensatory afforestation shall be transferred and mutated in favour of the State Forest Department before issue of the Stage-II clearance.

- vi) The user agency shall transfer the cost of raising and maintaining the compensatory afforestation for 10 years, at the current wage rate, to the State Forest Department.
- vii) All the funds received from the user agency under the project shall be transferred online to the Ad-hoc CAMPA in the Saving Bank Account pertaining to the State concerned.
- viii) The royalty of trees need not be demanded from the user agency as per Ministry's letter No.13-20/2015-CAMPA dated 09.06.2016.
- ix) The user agency shall comply with the guidelines for laying transmission lines through forest areas issued by Ministry vide letter No.7-25/2012-FC dated 05.05.2014 and 19.11.2014.
- x) The user agency in consultation with the State Forest Department shall prepare a detailed scheme for creation and maintenance of plantation of dwarf species (preferably medicinal plants) in right of way under the transmission line, and provide funds for execution of the said scheme by the State Forest Department.

- Any other conditions that Ministry of Environment, Forest & Climate Change may stipulate, from time to time, in the interest of conservation, protection and development (XX of forests and wildlife shall be complied by the user agency.
- The user agency and the State Government shall ensure compliance to provisions of the all Acts, Rules, Regulations and Guidelines, for the time being in force, as applicable to xxi) the project.

After receipt of the report on compliance to the conditions stipulated above, from the State Government of Odisha, final/Stage-II approval for diversion of the said forest land under Section 2 of Forest (Conservation) Act, 1980 will be issued by this Ministry. Transfer of forest land to user agency shall not be effected by the State Government of Odisha till final/Stage-II approval for its diversion is issued by the Ministry of Environment, Forest & Climate Change. However, the State Govt., if it so desires, may allow the user agency for commencement of work as per Ministry guideline issued vide letter No.11-306/2014-FC dated 28.08.2015.
