In compliance of the Rule 6(3 Me) of the Forest (Conservation) Rules, 2003 [as amended vide the Forest (Conservation) Amendment Rules, 2014; Forest (Conservation) second Amendment Rules 2014; and Forest (Conservation) Amendment Rules 2016], it is certified that **total 3.5000 Hectare** of forest land proposed to be diverted in favour of **Vice President (GA), Indraprastha Gas Ltd. Rajasthan State Office, Plont No. 248, 1st Floor, ASC Road, Gaurav Path, Vaishali Nagar, Ajmer** for **Laying of underground 8"/12" dia carbon steel gas pipeline along the NH-8 road form existing ROW From Ajmer Bypass Tiraha at Gagwana to Mangliyawas Tapping Point** in the district falls within the jurisdiction of [2.7770 Hectare of Forest Land of Tehsil Ajmer (Village Gagwana (0.2290 Hec), Ghooghara (0.1850 Hec), Rasulpura (0.2260 Hec), Guwaradi (0.2370 Hec.), Nareli (0.2150 Hec), Badlya (0.2100 Hec), Palra (0.2370) Hec), Sendariya (0.2040 Hec), Parbatpura (0.1930 Hec), Badgaon (0.1820 Hec.), Daurai (0.2350 Hec), Tabiji (0.1990 Hec) Saradhna (0.2250 Hec)] **0.7230 Hectare of Forest Land of Tehsil Peesangan** [Village Kesarpura (0.2660 Hec), Arjunpura Khalsa (0.1720 Hec), Arjunpura Jageer (0.1570 Hec), Mangliyawas (0.1280 Hec) **having no recorded population of Scheduled Tribes as per Census of India 2001 and 2011.**

It is further certified that :

(a) The Protected forest(s) namely (NH-8 Protected Forest Strip) involved in the above villages are plantation raised on non forest land on or after 13th December 1930 and were notified as PF vide notification no(s) F-3(16) Rev/8/76 dated August 5, 1978 (published in Rajasthan Gazette Vol 30, No. 20 dated August 17, 1978)

(b) Therefore, these PFs neither have residing Scheduled Tribes nor have Other Traditional Forest Dwellers (residing in the PFs for more than 75 years) having rights recognized under Forest Rights Act, 2006.
