- (a) The normal width clearance below each conductor or conductor bundle will be 3 m only. The trees on such strips may be felled but after stringing work is completed, the natural regeneration will be allowed to come up.
- (b) Outer strip may be left clear to permit maintenance of the Transmission Line.
- (c) In the remaining width of Right of Way felling/ pollarding/ pruning of trees will be done with the permission of the local Forest Officer whenever necessary to maintain the electrical clearance. Trees shall be allowed to be felled or lopped to the extent required, for preventing electrical hazards by maintaining the minimum 4 meter clearance between conductors and trees. The maximum sagand swing of the conductors are to be kept in view while working out the minimum clearance mentioned as above.
- (d) The Scheme for creation and maintenance of plantation of dwarf species in Right of Way under the Transmission Line, as prepared by the State Forest Department shall be implemented from the funds provided by the User Agency and a scheme for this shall be submitted.
