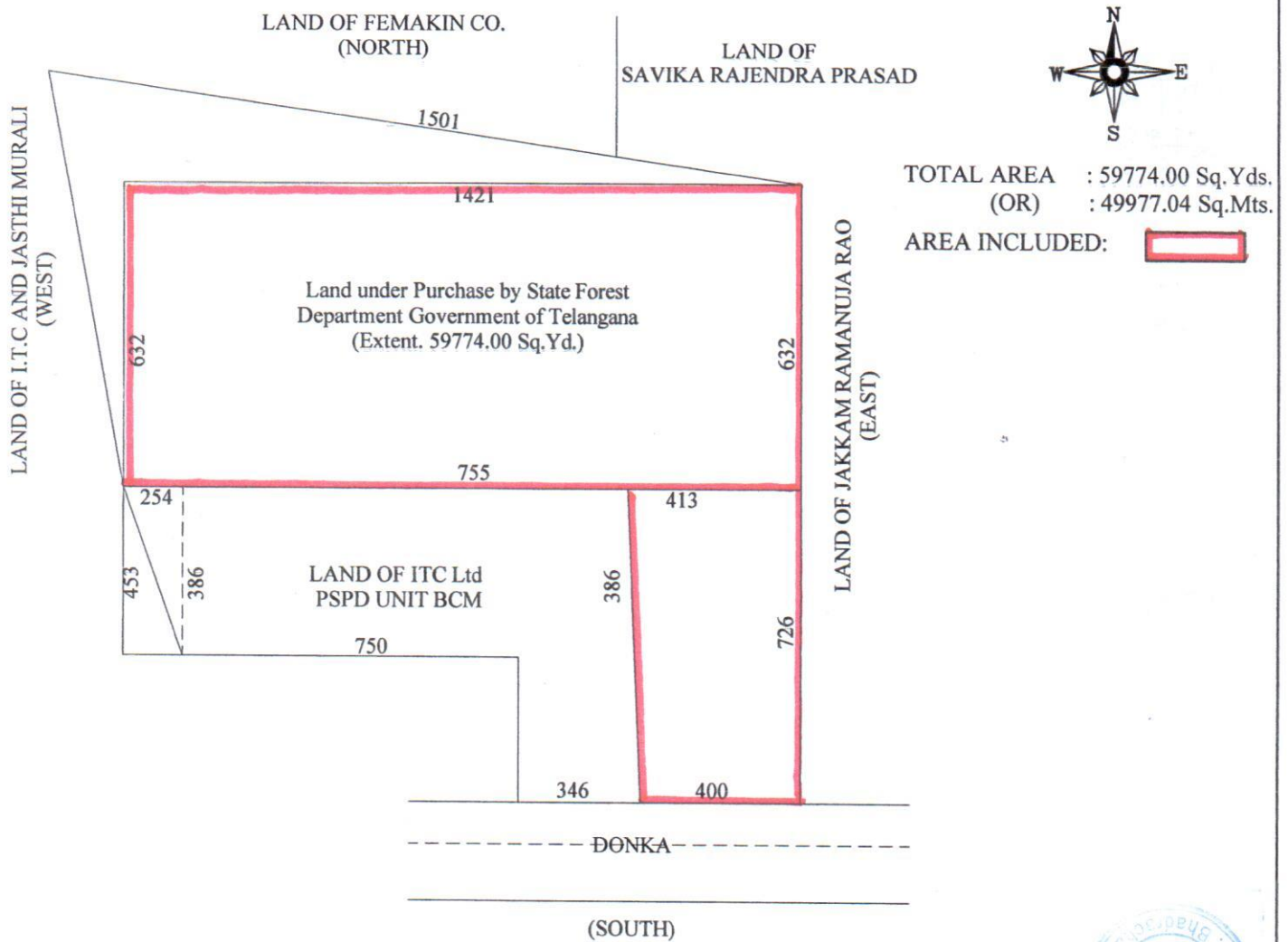
PLAN SHOWING NON FOREST LAND IN SY.NO. 440/18, 440/19 & 440/20, OF

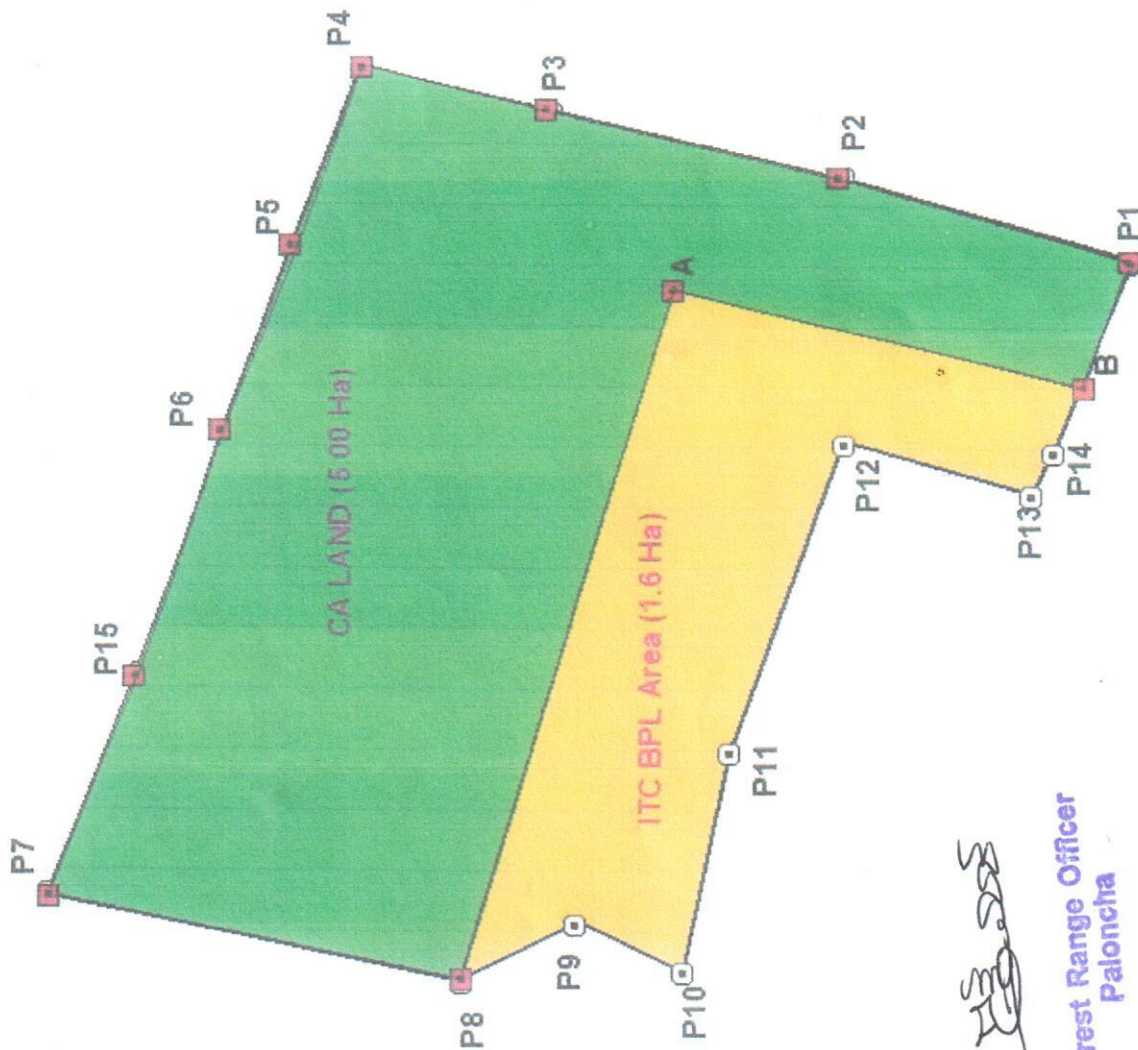

A suitable scheme shall be prepared to ensure that the whole CA area identified is covered with forestry species and submitted along with the compliance report for its approval.
- e) For effective protection of the CA land in future, the identified NFL shall be appropriately demarcated and fenced permanently at the cost of the user agency.
- f) The cost of compensatory afforestation at the prevailing wage rates as per the compensatory afforestation scheme and the cost of survey, demarcation and erection of permanent pillars if required on the CA land shall be deposited in advance with the Forest Department by the project authority. The CA will be maintained for 10 years. The scheme may include appropriate provision for anticipated cost increase for works scheduled for subsequent years.

5. Net Present Value:

- a) The State Government shall charge the Net Present Value(NPV) for the 4.2768 ha forest area to be diverted under this proposal from the User Agency as per the orders of the Hon'ble Supreme Court of India dated 30/10/2002, 01/08/2003, 28/03/2008, 24/04/2008 and 09/05/2008 in IA No. 566in WP (C) No. 202/1995 and as per the guidelines issued by the Ministry vide letters No. 5-1/1998-FC (Pt.II) dated 18/09/2003, as well as letter No. 5-2/2006- FC dated 03/10/2006;

- b) Additional amount of the NPV of the diverted forest land, if any, becoming due after finalization of the same by the Hon'ble Supreme Court of India on receipt of the report from the Expert Committee, shall be charged by the State Government from the User Agency. The User Agency shall furnish an undertaking to this effect.
6. User agency shall restrict the felling of trees to minimum number in the forest land proposed to be diverted and the trees shall be felled under the strict supervision of the State Forest Department, where ever necessary, and the cost of felling of trees shall be deposited by the User Agency with the State Forest Department.
 7. All the funds (compensatory levies) received from the user agency under the project shall be transferred/ deposited to designated CAMPA account of the State only through e-portal.
 8. The pipeline shall be laid down 1.5 m below the ground and after laying down of pipe line the ground will be leveled.
 9. The complete compliance of the FRA, 2006 shall be ensured by way of prescribed certificate from the concerned District Collector.
 10. User Agency shall obtain Environmental Clearance as per the provisions of the Environmental (Protection) Act, 1986, if applicable.
 11. The layout plan of the proposal shall not be changed without prior approval of Central Government.
 12. No labour camp shall be established on the forest land.
 13. No additional or new path will be constructed inside the forest area for transportation of construction materials for execution of the project work.
 14. The forest land shall not be used for any purpose other than that specified in the project proposal.
 15. The forest land proposed to be diverted shall under no circumstances be transferred to any other agencies, department or person without prior approval of Govt. of India.
 16. Violation of any of these conditions will amount to violation of Forest (Conservation) Act, 1980 and action would be taken as per the MoEF&CC prevalent guideline and as per Guideline F. No. 11- 42/2017-FC dt 29/01/2018.




17. Any other condition that the Ministry of Environment, Forests & Climate Change may stipulate from time to time in the interest of conservation, protection and development of forests & wildlife.

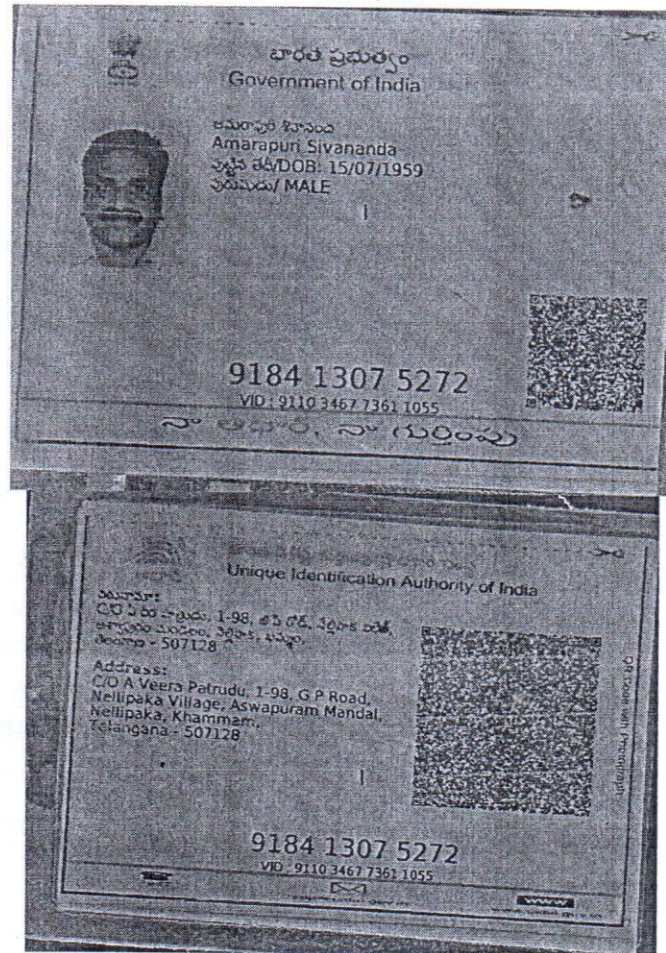

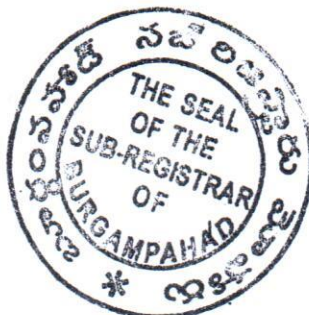
