The Forest Divisional Officer, Mahadevpur & Venkatapuram **(on condition stipulated on CA land)** are requested to submit the detailed demand note to this office for vetting of Nodal Officer (FCA), only after the demand is vetted by Nodal Officer (FCA), the demand notice to be issued on User Agency who in-turn has to upload the demand online for making payment through e-payment mode.

Important: The charges for felling, logging, transportation of project affected trees & the funds towards expenditure like boundary walls, stone pillars, demarcation charges etc., should be deposited with the Divisional Forest Officers concerned and the work should be undertaken departmentally in-order to ensure that the task of felling/ transportation / stone pillars etc., are undertaken faithfully and in the best interests of the forest. The funds deposited with the DFOs for carrying out such activities should be put to actual utilization only on the grant of 2nd Stage (final) clearance and / or working permission, whichever is earlier. 

- (v) Non-forest land identified for raising compensatory afforestation shall be transferred and mutated in favour of the State Forest Department before issue of the Stage-II clearance;
- (vi) Non-forest land which is transferred and mutated in favour of the State Forest Department for the purpose of compensatory afforestation, shall be declared as Reserved Forest under Section-4 or Protected Forest under Section-29 of the Indian Forest Act, 1927 or under the relevant Section(s) of the local Forest Act. The Nodal Officer must report compliance within a period of 6 months from the date of grant of final approval and send a copy of the original notification declaring the non-forest land under Section 4 or Section 29 of the Indian Forest Act, 1927, or under the relevant section of the local Forest Act as the case may be, to this office for information and record;
- (vii) The State Government shall charge the Net Present Value of the diverted forest land measuring 17.50 ha from User Agency as per the orders of the Hon'ble Supreme Court dated 28.03.2008 and 09.05.2008 in IA Nos.826 in 566 with related IA's in Writ Petition (Civil) No.202/1995;
- (viii) Additional amount of the Net Present Value (NPV) of the diverted forest land if any, becoming due after revision of the same by the Hon'ble Supreme Court of India in future, shall be charged by the State Government from User Agency. User Agency shall furnish an undertaking to this effect.
- (ix) The funds received from the User Agency towards Compensatory Afforestation and Net Present Value under this project shall be deposited in the Corporation bank account of the Telangana State CAMPA. The User Agency shall compulsorily deposit the NPV and other levies only by generating challan through the Ministry's website;
- (x) The layout plan of the proposal shall not be changed without the prior approval of the Central Government;
- (xi) Minimal disturbance should be ensured by creating labour camps outside the forest area as far as possible and it will be the responsibility of the user agency to ensure that the labourers & staff engaged in execution of work do not destruct nearby forest flora & fauna;
- (xii) The UA shall construct retaining walls and check walls wherever required by consulting the DFO concerned at the project cost;

- (xiii) The user agency shall comply with all other conditions/ suggestions as recommended by the DFO in part II of the proposal;

- (xxii) No labour camp shall be established inside the forest area and the dug out material / overburden shall be dumped outside the forest area;
- (xxiii) No storage of any material will be done in the forest area proposed;
- (xxiv) The State Forest Department shall translocate the trees, wherever feasible instead of felling, at the cost of user agency;

- (xxv) The total forest area utilized for the project shall not exceed 17.50 ha and the forest area diverted shall not be used for any purpose other than those shown in the diversion proposal. User Agency shall furnish an undertaking to this effect;
- (xxvi) The forest land proposed for diversion shall under no circumstances be transferred or sublet to any other agency, department or person without prior approval of the Central Government;
- (xxvii) User agency and the State Government shall ensure compliance to provisions of the all Acts, Rules, Regulations and Guidelines, for the time being in force, as applicable to the project;
- (xxviii) Any other conditions that the Central Government or Addl. PCCF(Central) of Regional Office, Chennai may impose from time to time in the interest of afforestation, conservation and management of flora and fauna in the area, shall be complied by the user agency;
- (xxix) The Progress of the Compensatory Afforestation as mentioned by the DFO, Mahadevpur Forest Division in Sl No 12 (v) (a) of part II i.e 51 ha of forest shall be monitored by the Circle Head and a copy of such monitoring report shall be forwarded to the Regional Office to upload the same in the web portal;


