

State Govt. vide ref 3rd cited has accorded Stage-I approval for the subject project with **xvii conditions** as stipulated therein. The Stage-I approval is communicated to the concerned for submission of compliance report vide ref 4th cited.

The CCF, Medak vide ref 8th cited has submitted condition-wise compliance report on **25 conditions**, instead of **17 conditions**, as stipulated in Stage-I approval. Reasons for submission of compliance report for **25 conditions** are not forthcoming from the report of the CCF, Medak.

Funds towards compensatory levies like NPV / Avenue plantation have been deposited into Ad-hoc CAMPA account (paid status is reflected online) and into PD Account of DFO concerned (as verified from approved APO).

Only due to non-submission of compliance report in a complete shape, compliance report to be submitted to Govt. is pending, for the last 4 years.

The casual approach of CCF, Medak and DFO, Sangareddy in submission of compliance report in such important Government Projects are noted with much displeasure.

In view of the above, the CCF, Medak is directed to submit condition-wise compliance report **in tabular form along with documentary evidences in triplicate**, for all the **17 conditions** stipulated in Stage-I approval alongwith all relevant enclosures to this office by **28/02/2022**, in-order to enable this office to submit consolidated compliance report to Govt., without any further delay.
