





CM's stick to rein in unruly MLAs, warns of cancelling membership

In a chit chat, Revanth Reddy said that his government did not want expulsions, suspensions and the entry of marshals in the House

Chief Minister A Revanth Reddy warned of cancellation of the membership of MLAs from the Assembly if they create nuisance in the Houses during the assembly session. The CM also took a strong dig at the leader of the opposition K. Chandrababu Naidu for not attending the budget session of the State Assembly.

The Chief Minister said that the previous BRS government had expelled Congress leaders

and became minister. Hence, I said, don't believe the words of Abba," said Revanth Reddy.

The Deputy CM Malla Bharti Vikramarka said that the Congress party gave ticket to Sabitha in 2014 and also in 2009. She was a minister for ten years. I was a CLP leader and Leader of Opposition (LOP). A Dalit was made the LOP for the first time. When she (Sabitha) was leaving the party, I told her that we will lose the LOP if she leaves and asked her to give another thought. Did she give a thought for once?" asked Bharti Vikramarka.

Procharya Raj Manjari Seethakka said that the two ladies told the Chief Minister that they will come into the party. The CM experienced the pain that these women gave. "They said we will come to Delhi and also took the appointment of senior leader Rahul Gandhi and skipped it at the last minute. The CM faced embarrassment and hence he wanted to caution KTR. He has not taken any name," said Seethakka. She also took exception to Sabitha, Indira Reddy giving a memorandum to the Government seeking disqualification of the party MLAs who have joined Congress party. She said the BRS pushed the Congress MLAs in the past, she asked,

the House. Such long debates in the assembly have never been held even in the erstwhile united AP. The sessions are being held for 17 hours every day," he said.

Revanth Reddy disclosed his close association with BRS MLAs Sabitha Indira Reddy and Santita Laxmi Reddy when the three of them were in the Congress party. Two cases were booked against him when he campaigned in support of Sabitha in 2018 elections and the cases were still pending, he said. Sabitha invited him to join Congress. She joined the ruling BRS party instead of supporting me and started campaigning against me in the elections, he added.

The CM maintained that he did not use any unparliamentary word in his speech and also did not utter a single rude word. He also questioned KCR for staying away from the assembly and asked why only KTR and Harish Rao were removed as floor leader because he is not a responsible leader. KCR wanted only power. After losing the CM chair, the BRS leader fought about people's welfare," he said.

"He claims that the ongoing budget session was not a short session. Everyone has got a chance to speak on the budget, on other bills and the appropriation bill, he added.

The State government presented the budget today in accordance with the allocation to the State in the Central government budget. The Centre presented the budget on July 23 and the State presented on July 25. It is mandatory to approve the appropriation bill by July 31. The length of the discussion is more important than the number of days, the CM said.

The issue came up during the discussion on the Appropriation Bill in the Assembly on Wednesday when Revanth Reddy made an indirect reference to women BRS MLAs who were earlier with Congress for leaving the party. Revanth Reddy asked KTR to be cautious with the sisters (Akkalu) behind him

stating that if he believes them, their lives will be miserable (using the Telugu phrase 'batuku bus stand'). This triggered a huge uproar in the House as the BRS members rushed into the Well of the House and raised slogans. They also demanded KTR to be cautious with the sisters (Akkalu) behind him

In response, Legislative Affairs Minister D Sridhar Babu said that the Chief Minister had not taken anyone's name, and asked why had joined TRS from Congress in the past? They were ministers for ten years and when Congress was criticised, they were flipping the benches, he said.

Revanth Reddy said that being in public life, there will be discussions on individuals, "It is a fact that Sabitha Indira Reddy blessed me when I joined Congress. I treated Sabitha as my sister, but when I was declared Malalgudi Lok Sabha candidate, she immediately joined TRS believing the deflating words of KCR
