It is informed that the Government of India vide reference 6<sup>th</sup> cited has conveyed Central Government **in-principle (Stage.I) approval** under Section 2 of Forest (Conservation) Act, 1980, for diversion of **4.148 ha** of forest land in Kothagudem Division for laying of Pipe Line in **Segment-25/6 (5<sup>th</sup> Incline)** for providing safe drinking water to Kothagudem District under Telangana Drinking Water Supply Project in favour of Superintending Engineer, TDWSP (RWS&S) Circle, Khammam, **subject to compliance of conditions stipulated therein**, which is communicated herewith.

The Forest Divisional Officer, Kothagudem is requested to raise demand note as per the actual rates **and submit the demand note to the Nodal Officer on email (ccfcampa.apfd@gmail.com and dcffca@gmail.com) for vetting. Only after vetting of the demand note by Nodal Officer, the Forest Divisional Officer should raise demand with the User Agency**, who in-turn has to upload the demand online on Ministry's portal, generate Challan & transfer the funds through online only into the specified Ad-hoc CAMPA account of Telangana State. The detailed procedure for generation of Challan and deposition of funds is available at **www.forestsclearance.nic.in** portal.

The mode of remittance for compensatory levies shall be through **e-payment portal of Ministry of Environment, Forest & Climate Change only** as per the guidelines issued by MoEF&CC, GoI (Ad-hoc CAMPA Wing).

**Note:** The charges for felling, logging, transportation of project affected trees & the funds towards expenditure like boundary walls, stone pillars, demarcation charges etc., should be deposited with the Divisional Forest Officers (now FDOs) concerned and the work should be undertaken departmentally in-order to ensure that the task of felling/ transportation / stone pillars etc., are undertaken faithfully and in the best interests of the forest. The funds deposited with the DFO for carrying out such activities should be put to actual utilization only on the grant of final approval (Stage-II) clearance or working permission, whichever is earlier. A clarification is issued in this regard by the Ad-hoc CAMPA Wing vide F.No.13-20/2015-CAMPA, dt.09.06.2016.

It is further informed that while submitting processed proposal to the Government / GoI, MoEF & CC, Chennai, the proportionate CA scheme amount was estimated as **Rs.37.3720 lakhs**, for **Segment-25/6 (5<sup>th</sup> Incline)** under Telangana Drinking Water Supply Project. Hence, it is requested to include the above CA amount in the demand note to be raised with the User Agency.

The Forest Divisional Officer, Kothagudem is further directed to instruct the User Agency to comply with the following in accordance with the instructions issued by the GoI, MoEF&CC, New Delhi vide F.No.7-23-2012-FC, dated 24.07.2013 communicated vide PCCF's Ref.No.45921/2001/F4, dated 23.08.2013.

1. Publish the entire forest clearances granted in verbatim along with the condition and safe-guards imposed by the Central government in two widely circulated daily news paper one in vernacular language and the other in English granted to the project proponent for the use of forest land for the non-forest purposes.
2. The copies of the forest clearance should also be submitted to the heads of local bodies, Panchyats and municipal bodies by the project proponents in addition to the relevant offices of the Government who in turn has to display the same for 30 days from the date of receipt of this reference.

In addition to above, the Forest Divisional Officer, Kothagudem is specifically directed to furnish a calculation sheet of NPV and other payments / copies of paper clippings about the publishing of forest clearance etc., along with the condition-wise compliance report to the undersigned through District Forest Officer, Kothagudem and Conservator of Forests, Kothagudem, for seeking final approval under Forest (Conservation) Act, 1980.

The transfer of forest land to the User Agency **shall not be affected** prior to the issue of **final approval/working permission**, whichever is earlier.

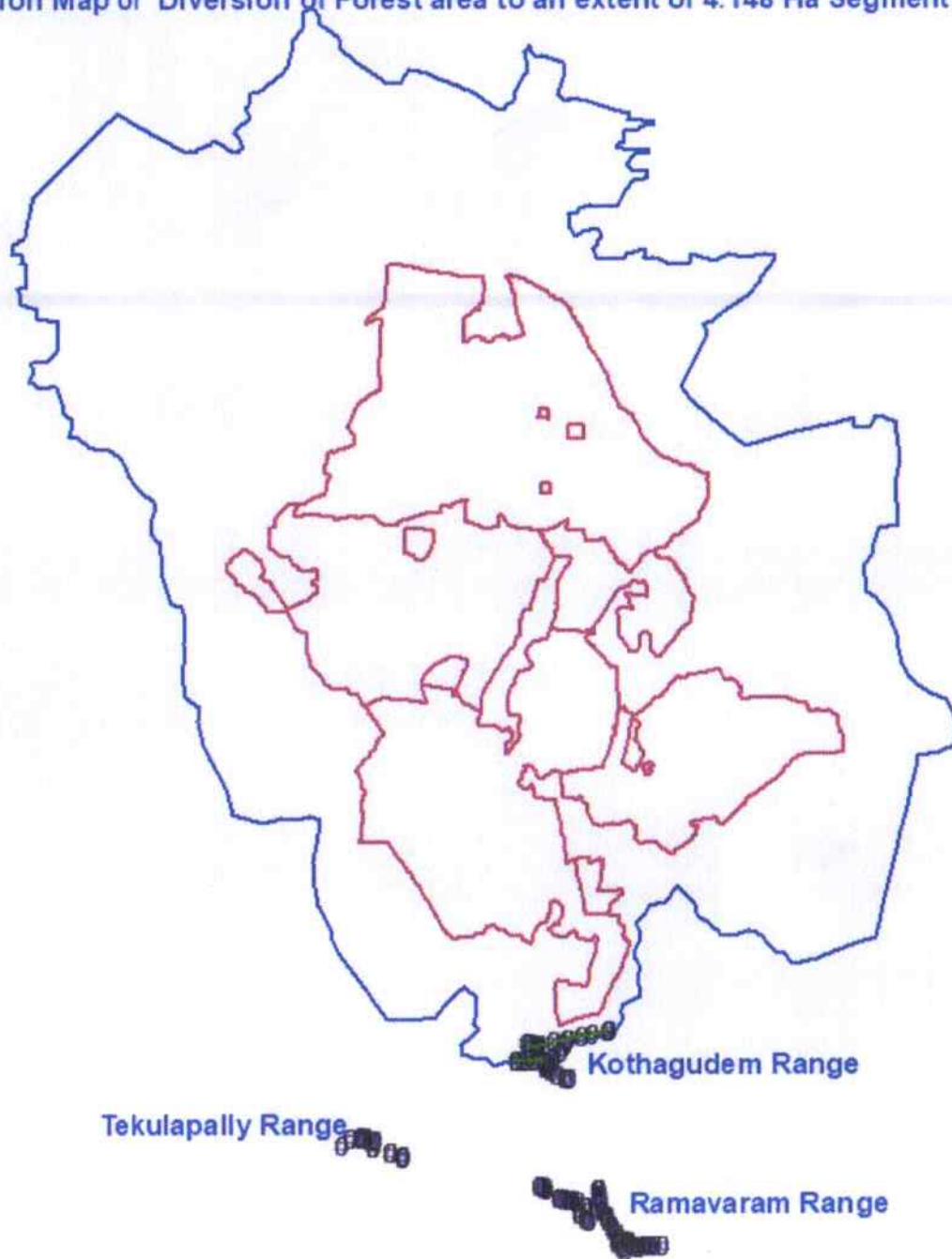
