The Government of Tamil Nadu has accorded Principal approval (Stage-I) vide 2nd reference cited, under section 2 of Forest Conservation Act, 1980 for diversion of 0.0768 ha Forest land for erection of 11 KV feeder (HT) EB posts from Ayyur to Pukkuzhi road across Kanguli Reserved Forest and Thiruikkonam Reserved Forest in Ariyalur Forest Division.


