IA Nos.130445/2020 & 130448/2020 have been  
filed by the State of Tamil Nadu and IA  
Nos.28062/2022-28064/2022 have been filed by the  
Bodhamalai Village Panchayat, represented by  
Panchayat Union Councillor seeking permission for  
removal of 260 trees grown over an area of 5.96  
hectares of Mallur Reserve Forest in Namakkal  
District of Tamil Nadu for constructing a new black



topped road from Keelur to Vadugammelur Kms 0/0 to 23/625.

CEC has considered the applications and recommended for grant of permission for felling 260 trees for the proposed road from Keelur to Vadugammelur subject to the following conditions :

i) For diversion and use of forest land approval of the competent authority shall be obtained under the Forest (Conservation) Act, 1980 and the conditions on which such approval is granted shall be fully complied with including payment of Net Present Value and compensatory afforestation will be undertaken in the non-forest area identified for the purpose;

(ii) The Right of Way of 4 feet wide provided in the reserved forest Notification may be modified so as to replace it with the new black topped road proposed to be constructed and a corresponding notification issued under the Tamil Nadu Forest Act.

(iii) The non-forest land for taking up compensatory afforestation made available by the user agency be chain link fenced on a 2 feet high foot wall; and

(iv) Addl. PCCF, Regional Officer of MoEF&CC at Chennai in coordination with the Forest Department of State of Tamil Nadu will monitor the



implementation of the compensatory planting of trees.

The applications are allowed subject to the conditions recommended by the CEC. It is made clear that the Net Present Value shall be paid by the State Government.

IA Nos.130772/2020 & 130776/2020 and 30227-30228/2022:

IA Nos.130772/2020 & 130776/2020 have been filed by the State of Tamil Nadu and IA Nos.30227-30228/2022 have been filed by the Bodhamalai Village Panchayat represented by Panchayat Union Councillor, seeking permission for removal of 102 trees grown over an area of 2.71 hectares of Pudupatti Reserve Forest in Namakkal District of Tamil Nadu for construction a new black topped road from Pudupatti to Kedamalai Kms 0/0 to 11/375.

CEC has considered the applications and recommended for grant of permission for felling 102 trees for the proposed road from Pudupatti to Kedamalai subject to the following conditions :

i) For diversion and use of forest land approval of the competent authority shall be obtained under the Forest (Conservation) Act, 1980 and the conditions on which such approval is granted shall be fully complied with including payment of Net Present Value and compensatory afforestation will be




undertaken in the non-forest area identified for the purpose;

(ii) The Right of Way of 2.74 meter wide provided in the reserved forest Notification may be modified so as to replace it with the new black topped road proposed to be constructed and a corresponding notification under the Tamil Nadu Forest Act.

(iii) The non-forest land for taking up compensatory afforestation made available by the user agency is chain-link fenced on a 2 feet high foot wall; and

(iv) Addl. PCCF, Regional Officer of MoEF&CC at Chennai in coordination with the Forest Department of State of Tamil Nadu will monitor the implementation of the compensatory planting of trees.

The applications are allowed subject to the conditions recommended by the CEC. It is made clear that the Net Present Value shall be paid by the State Government.
