
With reference to the above letter.3 cited, Stage – I approval was given by the State Government with the following conditions and are submitting herewith the Compliance report and Undertakings for further action.

Details of compliance on the conditions laid down by the Government of Tamilnadu in Stage – I approval for the Diversion of 0.8514 ha of forest land in Erumavettipalayam RF area for Up gradation of GNT road to New Erumaivettipalayam road @ 2/350 to 4/150 km in Tiruvallur District is furnished below:


