

Sir,

The MoEF & CC, Shillong has conveyed the "**In-Principle/ Stage-I Approval**" for diversion of 5.47 ha of forest land for construction of oil & gas well drilling including approach road at location TULD of mouja- Silachari under Gomati District by Oil India Limited under Gomati District subject to certain conditions stipulated vide letter F.No.3-TR C 028/2022-SHI/2793-94 dated 30th December, 2022.

2. As per the stipulations made by the Central Government, the total estimated cost for **Rs. 1,12,91,940/- (Rupees One crore twelve lakhs ninety one thousand nine hundred and forty)** only towards the cost of Net Present Value & cost for raising compensatory afforestation in compliance of conditions at Sl. No. A (1) & (2). The estimate is enclosed as **Annexure-A**.

3. It is also mentioning here that, the User Agency should pay the 2% Net Present Value (NPV) of the forest land in the PML in compliance of condition at Sl. No. A (4). The estimate will be shared separately.
