1.	The legal status of the forest land shall remain unchanged	Annexure-A
2.	The Compensatory afforestation shall be taken up by the Forest Department over double the degraded forest area of 2.00 ha in degraded forest land in Mouja-Sardingkhapara, CS Plot No.34, Kh.No.3/6, under Gumti Wildlife sanctuary at the cost of the user agency. As far as possible, mixture of local indigenous species shall be planted and monoculture of any species may be avoided.	Noted
3	The State Government shall charge the Net Present Value of the forest area to be diverted under the proposal from the User Agency as per the Judgement of the Hon'ble Supreme Court of India dated 30.10.2002, 01.08.2003, 28.03.2008, 24.04.2008 & 9.5.2008 in IA No. 566 in WP (C) No.202/1995 and as per the guideline issued by this Ministry vide letter No.5-2/2006-FC dated 03.10.2006 No. 5-3/2007-FC dated 05.02.2009. The requisite funds shall be transferred through online portal to Ad-hoc CAMPA account of the State concerned.	Annexure-B
4	The cost Compensatory afforestation at the prevailing wages as per the compensatory afforestation shall be deposited in the Compensatory Afforestation Fund of Tripura State manage by the Ad-hoc CAMPA through e-portal in the account of the Ad-hoc CAMPA. The CA will be maintained for 10 years. The scheme may include appropriate provision for anticipated cost increase for works scheduled for subsequent years.	Annexure-B
5	Additional amount of the Net Present Value (NPV) of the diverted forest land, if any, becoming due after finalization/revision of the same by Hon'ble Supreme Court of India on receipt of the report from the Expert Committee, shall be charged by the State Govt from the User Agency. The User Agency shall furnish an undertaking to this effect.	Annexure-C
