The State Government shall charge the Net Present Value (NPV) for the 0.0225 ha forest area to be diverted under this proposal from the User Agency as per the order of the Hon'ble Supreme Court of India dated 30/10/2002, 01/08/2013, 28/03/2008, 24/04/2008 and 09/05/2008 in IA No. 566 in WP(C) No. 202/1995 and as per the guidelines issued by the Ministry vide letter No. 5-1/1998-FC(Pt.II) dated 08/09/2003, as well as letter No. 5-2/2006-FC dated 03/10/2006, 5-3/2007-FC dated 05/02/2009 and 5-3/2011-FC(vol-I) dated 19/01/2-22 in this regard.	Necessary payment has been made against DN No 2377/8-14/OFC Jio Reliance dated-28-Sep-2022 of DFO Kurseong amounting of RS.22, 979/- through NEFT which is included in the same DN.
