Respected Sir,

In reference to the above mentioned communication pertaining to EOGEP's FDP of 13.54 Ha, the following response and justifications to points raised with respect to certain T&Cs mentioned in Stage – 1 approval is placed for information, consideration and further guidance:

Issue 1: The compliance of conditions of "in-principle" approval are submitted after lapse of more than 7 years. Proper justification for delaying in submission of compliance is need to be furnished.

The delay in compliance was primarily due to non – transfer of land earmarked for Compensatory Afforestation (CA) which was finally approved by Govt. of West Bengal (GoWB) in Sept., 2022 by virtue of an Inter Departmental Transfer (IDT) order and the same has been notified as “Protected Forest” via notification issued by GoWB.

We further submit as below: -

- I. Delay in transfer of CA land was purely a procedural matter wherein land earmarked for CA was vested as per laws of the state forcing EOGEP to complete the transfer through the process of IDT (transfer of vested land from Dept. of Land and Land Reforms to Dept. of Forest, Govt. of West Bengal).

We understand that IDT approval in favour of EOGEP was first of the kind in the state and hence the timeline stretched considerably. It should be noteworthy that EOGEP was in continuous touch with all concerned Nodal officers for appraisal and updation on the matter and the issue was extensively bought up and discussed during various meetings involving Land and Forest Dept. The approval was eventually accorded in Sep 2022 post which the land was immediately transferred to Forest Dept. after satisfactorily completion of trenching and pillaring activities.

- II. The above approval process was near to closure by first half of 2020 which was again unexpectedly prolonged due to advent of the pandemic situation which delayed the process by at least 2 years.
- III. Post IDT approval, CA Land was handed over by BL&LRO, Indpur, Bankura to ADFO, Bankura South Division, Forest Dept. on Feb 6th 2023. The complete Compliance report of the Stage 1 was thereafter submitted on 16th February 2023 on the online portal of MOEF&CC, GOI.

Issue 2: In this proposal, cost of CA was deposited in CAMPA account in the month of March 2017 and CA scheme was calculated based on old wages rate. The State Forest Department needs to confirm that whether compensatory afforestation may be possible with the CA funds deposited by the UA or needs to revised scheme based on new wages rate. Accordingly, additional CA amount may be deposited in CAMPA account by the User Agency, if required.

Previously, cost of Compensatory Afforestation amounting to Rs 14,04,000 was deposited to Ad-hoc CAMPA account on 3rd March 2017.

The revised estimated CA cost was informed as Rs 39,84,754 and accordingly demand was raised for balance payment of Rs 25,80,754 as per the Letter No 1546/28-L.L.C (LT) dated 02.08.2023 by DFO Bankura (South) Division. (Copy enclosed. Accordingly, additional amount of Rs 25,80,754/- was deposited on 10th October 2023.

Issue 3: As per Ministry's guideline No.5-3/2011-FC (Vol-I) dated 22.03.2022, the new rates of NPV will also be applicable on all the cases that were granted Stage-I/in-principle approval prior to 06.01.2022 and where even after lapse of 5 years, the Stage-II/ Final approval is not granted due to non-submission of complete compliance of the conditions stipulated in Stage-I/ in-principle approval. In this case, NPV amount deposited based on old rates. The State Forest Department required to revise the NPV amount and balance amount of NPV needs to be deposited in CAMPA account by the UA.

Previously, NPV amount of Rs.1,08,72,620 was paid to Ad-hoc CAMPA account on 3rd March 2017.

The revised NPV has now been calculated as Rs 183,75,269.40 and demand for the same was raised for payment of balance NPV of Rs 75,02,649.40 (Demand letter No 2624/8 dated 26.07.2023 issued by DFO Budwan Forest Division and letter No 2214/8 dated 26.07.2023 of Durgapur Forest Division). Accordingly, additional amount of Rs 75,02,649 was deposited on 10th October , 2023.

Issue 4: FRA certificate needs to be submitted in the Ministry's defined format.

The FRA issued by District Magistrate was originally submitted on September 2018. On subsequent intimation for obtaining FRA in the revised format, the concerned DM was approached for issuing a revised FRA Certificate and the same was finally issued on 12th August, 2023. (copy enclosed).


Issue 5: The condition wise comments of the State Forest Department on the compliance of "in-principal" are not enclosed. The same need to be furnish.
