The felling of trees/plants will be carried out under the strict supervision of the State Forest Department and the amount spent on felling of trees/plants will be deposited by the user agency to the State Forest Department.
	3.	As per the proposed CA Scheme, Compensatory Afforestation (CA) shall be taken up by the State Forest Department over degraded forest land in Compartment No.H43P16 Site Balsmand Branch Rd 70-72 L/Side by planting 248 plants at the cost of the user agency. The Plantation shall be done within one year from the date of issue of approval. As far as possible, a mixture of local indigenous species shall be planted and monoculture of any species shall strictly be avoided.
	4.	The compensatory plantation should be done within one year from the date of issue of this letter.
	5.	The Divisional Forest Officer shall upload the KML files of the degraded forest area accepted for raising compensatory afforestation in the E-Green watch portal of FSI, before handing over of forest land to the user agency.
	6.	The initial permission is given to this proposal for 15 years . After that the permission shall again be obtained from the Competent Authority.
