The subject envisages the use of forest land for **Issuance of Patta to the encroachers of Forest land encroached /occupied prior to 01/01/1977**. The site inspection of the land involved in the proposal has been done by me on dated **21.06.2019**. On inspection of the site, it is found that the land required by the user agency is a forest measuring **63.38 ha** coming under **Konni Forest Division**.

- i) The requirement of forest land as proposed by the user agency in Col. 2 of Part-I is unavoidable and is barest minimum required for the project.
- ii) There is no rare/ endangered/ unique species of flora and fauna found in the area.
