9. Specific recommendation of the D.C.F. for acceptance or otherwise of the proposal with reasons.

The user agency had applied for 2<sup>nd</sup> renewal of diversion of the Forest land of 567.087 Ha. of already broken up area (R.F. 512.617 Ha. and D.L.C. reported area 54.470 Ha.) within the lease hold area. and the Govt of India in Ministry of Environment & Forests have granted Stage -II clearance over an area of 567.087 Ha. of forest land (including 54.470 ha of DLC forest land) vide their letter No.8-32/93-FC (Vol-II) dt 24.9.2007. The Government of India in Ministry of Environment & Forests while granting Stage-I approval dtd. on 02.06.2006 imposed condition as per the condition No.(viii) asking the agency to surrender 10.190 Ha. of forest land and the remaining 32.425 Ha. of D.L.C. reported forest area. However, as per representation of User Agency, the Ministry modified condition no. viii in the Stage-I approval in such way as to approve inclusion of 1.185 Ha. of forest land for magazine area and 9.005 Ha. (of this 10.190 Ha forest land ) for safety zone and its maintenance. More over in its modified order, Ministry observed that the User Agency should submit a fresh proposal for diversion of 32.425 Ha. of D.L.C. reported forest area. Accordingly the User Agency in its present application has submitted the proposal for diversion of 32.425 Ha of DLC forest land.

The proposal for diversion of 32.425 Ha. of DLC forest land for mining of Iron and Manganese Ore may be recommended for seeking approval from the Govt. of India, M.O.E.F. under section 2 of Forest (Conservation) Act, 1980 (Amended).

The user agency shall bear the expenses for preservation and protection of Forests and Wild life @ one man-day daily for the entire lease period and share the hire charges of vehicle engaged in protection duty with other mine owners as would be decided by the Divisional Forest Officer during the total lease period.
