

SHORT NOTE ON ZUDPI JUNGLE PROPOSAL

Tahsil – Chamorshi

District – Gadchiroli

Catogiry of Proposal :- II – Encroachment (excluding commercial purpose) prior to 12/12/1996 using simplified procedure .

Area involved in this proposal 254.69 Ha. of Chamorshi Tahsil in Gadchiroli District, Maharashtra.

1. The Word Zudpi Jungle is in use in Vidarbha area since 1954-55 That the word “Scrub Jungle” is defined in Central Provinces Grazing & Nistar Act, 1948, it covers the lands having trees of 4 year of lesser and land covered by shrubs. It is submitted that these lands are of very low murmadi soil where growth of large trees are not possible. Therefore these lands are commonly known as Zudpi Jungle.
2. That the approval by Government of India was granted to allow Government of Maharashtra to use Zudpi Jungle for public purpose in view of the same Government of India Ministry of Environment and Forests (FC Division) has communicated vide its communication No. R.No.8-33/2-1-FC, the decision of 4th March 2014 to the Government of Maharashtra wherein proposed simplified procedure for submission of diversion proposal for Zudpi Jungle under the forest (conservation) Act 1980 has been prescribed. That as per clause 2 of the said communication the Ministry is empowered to accept submission of category wise proposal for diversion of Zudpi Jungle lands. It is further stated in the communication that the user agency may be SDO in part-I but the details of Zudpi land should be provided for different villages and khasra wise

separately along with the digital maps. The village-wise/Khasra wise details can be consolidated in Taluka level proposals. The proposals submitted by the State Government will be examined by the Ministry as per procedure laid in the Forest (Conservation) Rules, 2003. It is further stated that legal status of Zudpi Jungle Lands for diversion shall remain, The same the State Government shall not use the Zudpi Jungle land for the purpose other than specified in the diversion proposal.

3. As per the direction of State Government of Maharashtra by using simplified procedure for submission of diversion proposal for zudpi jungle under forest (Conservation Act, 1980) area of zudpi jungle under encroachment of Chamorshi Tahsil in Gadchiroli District in different villages are jointly inspected by Forest and Revenue authorities and that comes to 254.69 Ha. of land in 63 Villages Total Survey No's 439. The encroachments are excluding commercial purposes prior to 12/12/1996. That is to be consider for regularization therefore as per the directions the proposal of diversion has been prepared along with the required documents Joint Site Inspection Reports, Gramsabha Resolutions & Certificate under FRA 2006 are enclosed for verification.

Area involved in this proposal 13.89 Ha. of Chamorshi Tahsil in Gadchiroli District, Maharashtra.

1. The Word Zudpi Jungle is in use in Vidarbha area since 1954-55 That the word “Scrub Jungle” is defined in Central Provinces Grazing & Nistar Act, 1948, it covers the lands having trees of 4 year of lesser and land covered by shrubs. The proposals submitted by the State Government will be examined by the Ministry as per procedure laid in the Forest (Conservation) Rules, 2003. It is further stated that legal status of Zudpi Jungle Lands for diversion shall remain, The same the State Government shall not use the Zudpi Jungle land for the purpose other than specified in the diversion proposal.

3. As per the direction of State Government of Maharashtra by using simplified procedure for submission of diversion proposal for zudpi jungle under forest (Conservation Act, 1980) area of zudpi jungle under encroachment of Chamorshi Tahsil in Gadchiroli District in different villages are jointly inspected by Forest and Revenue authorities and that comes to 13.89 Ha. of land in 06 Villages Total Survey No's 33. The encroachments are excluding commercial purposes prior to 12/12/1996. That is to be consider for regularization therefore as per the directions the proposal of diversion has been prepared along with the required documents Joint Site Inspection Reports, Gramsabha Resolutions & Certificate under FRA 2006 are enclosed for verification.
